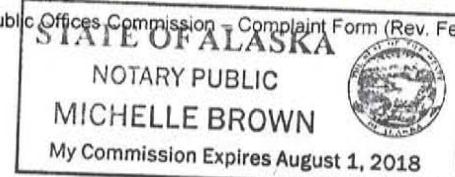

October 30, 2014

My Complaint is on the reporting Violation(s)below by Mr Dan Ortiz:

Mr. Dan Ortiz's (Ortiz for Alaska House District 36 Campaign) campaign disclosures, financial contribution limits, and a number of questionable cash transactions are being made and completed which do not follow the APOC campaign disclosure regulations and requirements as is required by State of Alaska Statute AS 15.13, and 2 AAC 50.250-254.

The specific violations, description, and source are noted below:

1. Advertising Source Paid for by: Mr. Ortiz has an ad running in the Wrangell Sentinel on October 23, 2014. It does not include the required campaign citations of who has sponsored, written, and paid for the ad publication. See the Wrangell Sentinel newspaper copy attached.
2. Financial Contributions: Ortiz campaign disclosure filing on the APOC site shows that he has accepted more than the state allowable contribution cap of \$500 from one individual a Mr. Greg Middag. Middag's contributions when summed up for the election cycle total \$600 which is \$100 in excess of the allowable campaign contribution limit per person. Dates of the contributions' are \$200 on February 28 + \$100 on August 25 + \$300 on October 25, 2014. Attached print out of APOC items listed. (*Attachment 3a, 3b, 3c*).
3. Financial Accounting & Transactions: Mr. Dan Ortiz contributed \$120 in cash to himself on August 25 based on the APOC filing submitted (on attached printout). This appears to have several violation issues associated with the seemingly linked transaction(s) on the amended/corrected filing, as well as, raising more serious questions or suspicion as to what exactly is going on due to: (*Attachment 3a and 3c*).
 - a. This is a violation of the \$100 cash limit allowed from an individual donor.
 - b. the information in the APOC amendment/correction raises questions since the original report showed Mr. Greg Middag contributing \$120, followed by a corrected filing showing Mr. Middag contributing \$100 and Mr. Dan Ortiz as contributing \$20 to himself. There appears to be financial accounting and tracking issues with cash received that warrant investigation of the circumstances.

I would appreciate the APOC office looking into these matters and responding back as it appears the two candidates of House District 36 are being held to and following completely different standards.

President and other posts picked for hospital board

Officer positions were decided at the Wrangell Medical Center Board's monthly meeting Oct. 15. Present were Judy Miller, Barb Conner, Barbara Mason, Cori Rasmussen and Dorothy Swartz, while among those absent were many at-large members: Woody Wilson and Terri Henson.

Wrangell Medical Center's executive Marla Sanger provided over the meeting to begin with, while the board elected its new officers following the Oct. 7 election.

Henson nominated herself to again serve as board president, which was unanimously approved. Mason was nominated and elected to be vice-president, Conner as treasurer, and newcomer Robinson as board secretary.

Following the election, Mason took over presiding the meeting from Sanger since Henson was not elected to the newly designated position.

Giving her report, Sanger told the board the hospital has been "very busy," continuing with staffing shortages among nurses and medical staff. On the administrative side, chief financial officer Dana Strong had also left the employ of WMC earlier this month.

Mary Jo Pillman of the hospital's human resources department again recommended a new position during the interim at the time for nearly repeating approaches.

"I feel pretty comfortable that we will get through this without a hitch," Sanger said.

Pillman will receive some training that will help acquaint her with the new responsibilities. In the meantime, a replacement suitable candidate will be sought. Suitable candidates will be expected to handle not just the hospital's finance and reporting, but also those of Alaska Island Community Services.

Sitting in as the City and Borough Assembly's representative to the meeting, Stephen Prysack expressed concern that the hiring away of a professional person by joining those CFO responsibilities might adversely affect Wrangell.

"Every family really counts," he told the board, asking that it

keep the town's economic interests in mind when making staffing decisions.

During the meeting, Sanger had also recommended her presentation regarding the plan for a new hospital facility to the Borough Assembly. She said the assembly WMC staff are currently going over previous plans to build a new hospital updating information and determining which aspects will have to be started anew.

The regional director of the United States Department of Agriculture and an engineer with the state of Alaska visited Wrangell this week in order to assist in that regard.

"They were very encouraging with respect to where we're at right now," Sanger said. They had told her WMC has enough of the project's conceptual framework to begin the application process to a USDA loan.

However, she added there will be a number of steps to take before that can happen, such as conducting a feasibility study of the hospital's finances.

"There are many things we

don't know yet," she said, but "we have enough on paper to start moving forward."

The hospital facilities will also require new fire alarm sensors; at a recent test, 29 of the center's 100 smoke detectors were not functioning correctly.

"The devices we have are fairly old," Sanger said. She recommended replacing all of the devices with a set that might be used eventually in a new facility.

"There's been lots of different kinds of training," Sanger added, with a refresh course being offered to staff this week on proper containment procedures in light of national Ebola concerns.

A speech therapist will also be arriving, and she explained the hospital will be looking into acquiring an occupational therapist as well.

"There's some advantage to that," Sanger suggested, by expanding clinical services to cover a wider variety of needs.

Nurse Natalia Jabsch was announced as the hospital's employee of the month.

A possible quorum of the board will be present at a meet-and-greet reception at 4 p.m. at the ACIS clinic.
