On January 7, 2000 the Commissioner of the Department of Natural Resources (DNR) adopted the Kenai Area Plan. The plan designates land uses and sets management intent and guidelines for approximately 5.3 million acres of state lands in the Kenai Peninsula Borough. On this same date he also signed a Mineral Closing Order 738, Leasehold Location Order 21, and Classification Order SC-99-002 that applies to the planning area. Consistent with the Kenai Area Plan, the Commissioner also designated four areas as Special Use Lands on January 11, 2000.

The plan classifies and reclassifies state-owned uplands, tidelands, shorelands, and submerged lands within the Kenai Planning Area. The plan also includes areawide guidelines and management intent for state lands. Mineral Closing Order 738 applies to 42 acres of state shorelands (streambeds) on the lower Russian River in accordance with AS 38.05.185(a). Under Leasehold Location Order 21, the Department will restrict new mining locations on the beds and within 200 feet of six river systems (approximately 8,700 acres) to leasehold locations under AS 38.05.205. Additional stipulations on mining will apply to these leasehold location areas. The six rivers are: Kasilof River, Ninilchik River, Stariski Creek, Deep Creek, Anchor River, and upper Russian River.

Also adopted are four new Special Use Land designations under 11 AAC 96.010(b) for the state-owned tidelands and submerged lands in Resurrection Bay and along the outer coast of the Kenai Peninsula, the tidelands and submerged lands adjacent to Lake Clark National Park and Preserve, and on state-owned uplands along the Exit Glacier Road.

Where the Kenai Area Plan boundaries overlap with existing DNR area and management plans in the planning area (Susitna Area Plan, Bristol Bay Area Plan, Prince William Sound Area Plan, Deep Creek Area Management Plan, and the Nuka Island and Vicinity Management Plan), these plans are amended under 11 AAC 55.030 and superseded by the Kenai Area Plan.

The Kenai Area Plan incorporates the Caribou Hills Management Plan and makes minor changes to the plan intent and boundary under 11 AAC 55.030. This action also makes minor changes to the Caribou Hills Special Use Lands designated under 11 AAC 96.010(b). Policies and guidelines from existing DNR Site-Specific Plans are incorporated into the Kenai Area Plan with some minor changes to intent and guidelines.

The Alaska Department of Transportation and Public Facilities (ADOT&PF) is developing plans to remove a small hill that penetrates the Sitka Airport safety area near the threshold of Runway 29. The penetration is an encroachment into Federal Aviation Administration (FAA) Part 77 airspace. The hill contains an abandoned ammunition bunker from World War II in which deceased Mt. Edgecumbe

Hospital patients were interred between 1947 and 1963, first by the Bureau of Indian Affairs, then by the Indian Health Services (IHS). It contains the remains of 113 Alaskan Natives and non-Natives. The Sitka Tribe of Alaska, under contract to ADOT&PF, is arranging the relocation of human remains, in accordance with the wishes of lineal descendents or next of kin.

Upon removal of human remains from the bunker, the hill would be removed and resulting material would be used to fill in nearby low areas.

The U.S. Navy constructed the bunker in 1942 as part of the Sitka Naval Operating Base, which has since been designated a National Historic Landmark. ADOT&PF, on behalf of IHS and FAA, is investigating the historical significance of the bunker as a mausoleum and as a contributing element to the Landmark. If the bunker is determined to be a contributing element of the Landmark, or if it is eligible for the National Register of Historic Places because of its use as a mausoleum, adverse affects resulting from demolition of the bunker will be resolved in consultation with the State Historic Preservation Officer and the Advisory Council on Historic Preservation.

Two alternatives are being considered for this project:

- · Alternative 1. Proposed action. The human remains in the bunker would be relocated and the hill penetrating Part 77 airspace would be removed.
- · Alternative 2. Do nothing. This alternative would not remove the airspace penetration, nor would human remains interred in the bunker be relocated.

ADOT&PF is currently evaluating the social, economic and environmental impacts of this project. In accordance with the regulations of the National Environmental Policy Act and Section 106 of the National Historic Preservation Act, your comments on the project are requested, including your views on the historical significance of the bunker and its potential eligibility for the National Register.
