On December 4, 1997, Alaska Power & Telephone submitted an operating permit application for the Haines Generating Station as required by 18 AAC 50, effective January 18, 1997. Alaska Power & Telephone submitted additional information on February 27, 1998.

Emissions: The significant air contaminant emission sources are the diesel electric generators. The potential annual emissions of regulated air contaminants at the facility will not exceed 376 tons/yr: 8 tons of Particulate Matter (PM-10), 249 tons of Nitrogen Oxides (NOx), 42 tons of Sulfur Dioxide (SO2), 70 tons of Carbon Monoxide (CO), and 7 tons of Volatile Organic Compounds (VOCs).

Department Preliminary Review: Based on review of Alaska Power & Telephone's Operating Permit

application, ADEC concurs that the Haines Generating Station and other sources will comply with emission standards listed in 18 AAC 50.040-090. As proposed, allowable emissions will not cause any violations of the ambient air quality standards and increments. The Department has drafted a Statement of Basis including a preliminary permit decision to issue an operating permit for the Haines Generating Station.

2. The department intends to adopt new regulations at 7 AAC 50.800 - 895 (Article 9) for the licensure, operation, and departmental supervision of facilities providing residential psychiatric treatment to emotionally disturbed children and youth. These regulations implement and make specific the licensing requirements applying to RPTC's in conformance with the provisions of ch. 107, SLA 1998. To become licensed, an RPTC must follow all provisions, standards, and procedures applying to residential child care facilities described in 7 AAC 50.005 through 7 AAC 50.900, except where Article 9 sets out differing requirements.

While in no way exhaustive of the items addressed, the following list identifies significant topics covered in Article 9:

- · Define and create programmatic requirements for semi-secure and secure RPTC's.
- · Set standards for qualifications of medical, clinical and other care giving staff of RPTC's.

· Set standards for orientation, initial training, and ongoing training for RPTC staff.

• Define admission criteria for severely emotionally disturbed children or youth considered for placement in an RPTC.

• Define admission criteria for voluntary admission of children/youth to a secure unit or secure program within an RPTC.

• Set standards regarding the release of an RPTC resident from secure care and for re-admission to secure care.

• Set standards for early and proactive discharge planning, treatment team participation, and transition of each RPTC resident to community care or home.

• Set requirements for independent review of extended placements of children/youth admitted on a voluntary basis to ensure that continued care in an RPTC remains appropriate.

· Set child-to-caregiver ratios in RPTC's.

• Expand on the basic licensing standards for behavior management of RPTC residents and expand the requirements for facility record-keeping regarding the use of behavior management techniques, including seclusion or restraint.

• Define specific classes of medication that a physician may not prescribe for residents of an RPTC, set out criteria for "informed consent" to medications by the parent, Indian custodian, or guardian of the resident, and expand the requirements for facility record-keeping regarding the use of all medications within an RPTC.

· Require an RPTC to offer a resident grievance process.

• Require an RPTC to provide educational services certified by the local school district.

3. The department intends to amend the definition article of Community Care Licensing, 7 AAC 50, by re-numbering it as Article 10. We also propose to add the category of RPTC to the definition of full time care facility, add a definition of the Global Assessment of Functioning Instrument, add a new definition for RPTC, and amend the definition of semi-secure.

The department recognizes that the proposed Article 9 will require an RPTC to meet licensing requirements in addition to requirements related to the receipt of medical assistance reimbursement as set out in 7 AAC 43. We invite reviewers to recommend changes to the proposal, including cuts to licensing requirements and ways to make these regulations easier to understand, and to comment regarding the potential cost of compliance. The department may make additional changes that appear necessary after reviewing public comments.
