ALASKA INDUSTRIAL DEVELOPMENT AND EXPORT AUTHORITY

Notice is given that the Alaska Industrial Development and Export Authority (AIDEA), under the authority of AS 44.88.080, proposes to adopt regulation changes in Title 3, Chapter 99 of the Alaska

Administrative Code, dealing with AIDEA's lending program, to implement AS 44.88.085, 44.88.090, 44.88.095, 44.88.150, 44.88.155, 44.88.159, 44.88.212, 44.88.525, 44.88.530, 44.88.535, 44.88.540, 44.88.545, and 44.88.900.

The title of Article 1 of Chapter 99 is proposed to be changed to reflect the regulatory changes described below.

3 AAC 99.100 is proposed to be changed to alter the applicability of Article 1 to include AIDEA's financing programs, regardless of whether they are financed through tax-exempt bonds or bonds that are not tax-exempt.

3 AAC 99.110 is proposed to be changed to consolidate the application process by eliminating the requirement for a preliminary application, to describe the information to be included in an application, to specify the actions to be taken by AIDEA upon its preliminary determination eligibility of a project to participate in the conduit revenue bond program.

3 AAC 99.120 is proposed to be changed to clarify the application process following a preliminary determination of eligibility under proposed 3 AAC 99.110.

3 AAC 99.130 is proposed to be changed to specify that AIDEA will cooperate with an applicant to obtain information needed to make a determination with respect to an application, and to reflect that a financing agreement may be entered into with an originator.

3 AAC 99.140 is proposed to be changed to provide for new issuance fees for certain types of bonds, to specify fees for certain types of board actions, and to make non-substantive grammatical changes.

3 AAC 99.160 is proposed to be changed to reflect a new program name referenced in 3 AAC 99.200 - 3 AAC 99.290.

The title of Article 2 of Chapter 99 is proposed to be changed to reflect the regulatory changes described below.

3 AAC 99.200 is proposed to be changed to reflect the change in the name of the program.

3 AAC 99.210 is proposed to be changed to reflect the fact that bonds might not be issued to provide money for a particular loan, and to provide that AIDEA will adopt an eligibility resolution only if AIDEA's portion of the loan is greater than or equal to one million dollars. If AIDEA's portion of the loan is less than one million dollars, AIDEA will not adopt an eligibility resolution.

3 AAC 99.220 is proposed to be changed to reflect the proposed changes to 3 AAC 99.210, to increase the amount of the application fee for loan participations, to provide for a credit of the application fee against the commitment fee and funding fee if the application is granted, and to remove references to the Uniform Standards of Professional Appraisal Practice.

3 AAC 99.230 is proposed to be changed to provide that AIDEA participation in refinancing is subject to the added requirement of permissibility under the Internal Revenue Code.

3 AAC 99.240 is proposed to be changed to provide that AIDEA participation in refinancing is subject to the added requirement of permissibility under the Internal Revenue Code.

3 AAC 99.250 is proposed to be changed to remove a provision for downward adjustment of AIDEA's share of a participation loan funded by tax-exempt bonds, to clarify the method of calculation of the initial rate of interest to be charged on a participation loan, and to make non-substantive grammatical changes.

3 AAC 99.260 is proposed to be changed to provide for multiple extensions of a loan commitment.

The title of Article 3 of Chapter 99 is proposed to be changed to reflect the regulatory changes described below.

3 AAC 99.300 is proposed to be changed to make non-substantive grammatical changes.

3 AAC 99.320 is proposed to be changed to increase the amount of the application fee for loan participations, to provide for a credit of the application fee against the commitment fee and funding fee if the application is granted, and to remove references to the Uniform Standards of Professional Appraisal Practice.

3 AAC 99.350 is proposed to be changed to remove a provision for downward adjustment of AIDEA's share of a participation loan funded by tax-exempt bonds, to remove a requirement that the originator retain a forty percent share of a participation loan after refinancing, to clarify the method of calculation of the initial rate of interest to be charged on a participation loan, and to make non-substantive grammatical changes.

3 AAC 99.360 is proposed to be changed to provide for multiple extensions of a loan commitment.

3 AAC 99.730 is proposed to be changed to make non-substantive grammatical changes.

3 AAC 99.760 is proposed to be changed to allow AIDEA to waive the priority of a lien or security interest required under 3 AAC 99.730, to increase the share of an existing debt for which AIDEA may provide a guarantee, and to correct a non-substantive typographical error.

3 AAC 99.930 is proposed to be changed to remove the definition of the term "fair market value," and to reflect the fact that 3 AAC 99.710(d) has been previously amended to provide for more than four regions.

Notice is also given that any person interested may present written comments relevant to the proposed action, including the potential costs to private persons of complying with the proposed action, by writing to the AIDEA, Attention: J. Under Alaska law, the Department of Community and Economic Development must establish fee levels so that the total amount of fees collected for an occupation approximately equals the actual regulatory costs for the occupation. The Department of Community and Economic Development has reviewed the income and expenses for the occupational licensing program listed below and proposed fee changes that reflect, to the extent possible, the actual costs of the activities under this occupational licensing area.

The proposed regulations set fees for the following area:

12 AAC 02.195, DIETITIANS AND NUTRITIONISTS, the department is proposing to adopt a new section that establishes fees for dietitians and nutritionists.

ambient air expected to be emitted by Soil Remediation Units. The report tabulated the concentrations of the chemicals in the soil that could be remediated at various processing rates for different soil remediation projects lasting from one to 4320 hours.
