FINDING OF EMERGENCY

The Alaska Board of Game finds that an emergency exists and the attached regulations are necessary for the immediate preservation of the public peace, health, safety or general welfare. The facts constituting the emergency include the following:

Sitka black-tailed deer were introduced to Kodiak Island from southeast Alaska in a series of transplants between 1924 and 1934. The population became established on the entire Kodiak archipelago (Unit 8) by the 1960s. Although objective population data are unavailable, the department estimates that the population contained 80,000 deer by the late 1990s. The deer population management goal for Unit 8 is to maintain a deer population that will sustain an annual harvest of 8,000 deer. The average annual harvest during the past 5 years has been 8,634 deer. Liberal state hunting seasons have allowed use of the harvestable surplus, and have provided for subsistence and recreational uses as well as expanding commercial uses.

This deer population experiences periodic declines due to winter mortality, especially when snows restrict animals to narrow beach fringes or exposed capes. In several of these areas, there is evidence of overbrowsing. Severe winter conditions during 1998-1999 resulted in an estimated mortality rate of 30-50% of the pre-winter population, and the harvest in 1999 is expected to decline proportionally. The proportion of the population that died during the 1998-1999 winter was higher than in previous years, and current hunting regulations would probably impact the productivity and recovery of the population. About 25% of the average annual harvest occurs during December when deer move onto beaches. Although the population would probably survive without intervention, the recovery period may be longer if a significant number of does are killed this season.

#### ADOPTION ORDER

Under the authority of AS 16.05.255, AS 16.05.258, and under a delegation of authority from the Board of Game under AS 16.05.270, the attached regulations are therefore adopted as emergency regulations to take effect immediately as provided in AS 44.62.180 (3).
