The following changes/additions are required:

1. **Question:** It seems pretty clear that you are not going to spend in excess of \$280,000 for camp and new generator. Any preference (Ak Vet or Ak Business) is only a consideration as far as determining "points" which in the end, determines who's proposal you are going to accept. Am I correct so far?

Response: Yes, preferences will only be used for evaluation and award of the contract. The maximum budget for purchase of the camp is only \$280,000.00. The generator is an optional purchase that would only be exercised if budget allows it after purchase of the camp.

2. **Question:** 2.12 FOB point requires that any one making a proposal utilizing units from outside Alaska, are required to pre-pay the freight and get the units to Ketchikan and at that point, can submit and expect to be reimbursed for the cost incurred to transport units from "a point in the US" to Ketchikan. Does this cost to deliver the units that can easily be \$20-25,000 fall under the \$280,000 cap?

Response: Yes the \$280,000.00 cap includes all costs associated with performance of this contract to include delivery of the units to Ketchikan.

3. **Question:** Your RFP as I read it, encourages the purchase of units that do not currently reside in Ketchikan, if it is your intent to reimburse transportation cost and potentially incur a delivered Ketchikan camp cost that exceeds \$280,000.?

Response: As stated before and throughout the RFP the \$280,000 budget includes all costs associated with purchase and delivery of the units to Ketchikan to include delivery of the units to Ketchikan. The RFP does not encourage the purchase of units not currently residing in Ketchikan. An offeror with units in Ketchikan has the same opportunity to offer a proposal as any other offeror.

4. **ADD the following to paragraph 5.02.b.3:** At a minimum a tandem axle trailer with dual wheels is required for portable camp units to facilitate moving the units from the barge onto the beach.
