**RFP TITLE: Mobile Food Services for the Division of Forestry**

**RFP DEADLINE FOR RECEIPT OF PROPOSALS: 2:00 p.m. on May 16, 2017**

This amendment addresses changes to the RFP identified by the Division of Forestry as of April 25, 2017. This amendment is for informational purposes only and need not be returned to the State.

**1. CHANGE paragraph 5.02.d., Meals, paragraph 2, to read:**

2. Cooking and serving equipment, serving utensils, eating dishes, and supplies. All cups will be Styrofoam and contain a minimum of 12 ounces. Cups provided for coffee, tea, and other hot drinks must be able to withstand a minimum temperature of 180 degrees Fahrenheit. All disposable eating utensils will be factory sealed in plastic and at least of medium weight. Eating dishes will be Styrofoam or equivalent; paper plates, bowls, clamshells, or other eating dishes will not be acceptable.

**2. CHANGE paragraph 5.02.j to read:**

j. Garbage cans with bio-based liners for MFSU to include all peripheral food handling, preparation areas, and dining area. Only garbage bag liners are required to be bio-based. To minimize the attraction for flies and other insects the State desires that the contractor dispose of garbage between meals, however, actual garbage disposal will be at the contractor's discretion.

**3. CHANGE paragraph 5.02.v to read:**

v. The State's expectation is for a meal period not to exceed 4 hours. Actual times will be determined on site by the FDUL. There is no requirement for the number of servings per hour but the Contractor should serve meals as quickly as possible and the expectation is that the Contractor should be able to serve 200 meals per hour.

4. **CHANGE** paragraph 5.03.c, "Contain all grease products" on page 35 of the RFP to read:
- c. Contain all grease products in Contractor-provided grease containers for proper disposal by the State.
5. **DELETE** paragraph 5.04.h, Containers for grease disposal on page 37 of the RFP. As specified above, the Contractor will be responsible for providing grease containers.
6. This amendment is for informational purposes only and need not be returned to the State.
