Item 2: Below is an inquiry from a proposer received by DEC July 27, 2017. Following the inquiry is the DEC response.

Inquiry 1: "p. 25: "It is anticipated that the majority of the Regional Haze SIP work will be accomplished in FY18 and FY19.

p. 26: "For purposes of the RFP, Offerors shall focus on the FY18 basic deliverables when developing their proposal...The Contractor shall, for purposes of this RFP, perform the following Tasks identified for the technical support and development of the Regional Haze SIP...and the Anti-Idling Program....DEC anticipates not all \$150,000 will be needed to complete all 4 tasks.

p. 37: The first row of the Table in Section 7.01 (as amended) reads: "FY18 Tasks 1-5 and Potential Future Deliverables"

So does this mean all of the work for all Tasks 1-5 (Regional Haze work and anti-idling work) need to be done in FY18 and the total needs to be less than \$150K? Or is the \$150k intended to just cover the Regional Haze tasks? Or maybe just the portion of the Regional Haze tasks that will be done in FY18?"

Response 1: All of the work for all Tasks 1-5 (Regional Haze work and anti-idling work) should be \$150,000 or less. Proposals received with an amount higher than \$150,000 will be deemed non-responsive.

The cost proposal needs to address Tasks 1-4 and should be less than \$150,000 to account for funding for Task 5 but a cost analysis for Task 5 is not necessary.
