Public Notice

ADL 232946: Lynne Lake submerged electric cables near Willow, Alaska
Applicant: Matanuska Electric Association, Inc.

Pursuant to Alaska Statute 38.05.850, the Department of Natural Resources (DNR), Division of Mining, Land, and Water (DMLW), Southcentral Regional Office is considering a request from Matanuska Electric Association, Inc. to create a public utility easement for submerged electric cables to be installed across a portion of the bed of Lynne Lake, near Willow, Alaska. The public utility easement is proposed to be located on State-owned, DMLW-managed submerged land within:

- Section 29 of Township 19 North, Range 4 West, Seward Meridian, Alaska

The requested public utility easement would be approximately 1,500 feet in length, 30 feet in width, and would occupy approximately 1.03 acres of State land. The requested easement is highlighted in yellow on the attached map.

Members of the public and interested parties are invited to comment on this project. **DMLW must receive comments no later than 5:00 pm September 29, 2017.** In order to be given full consideration, all comments should be in writing and should clearly explain the facts on which they are based and how they pertain to the requested easement.
