REQUESTED ACTIVITY: Prince William Sound Science Center has requested an amendment and reissuance and to the previous authorization to now deploy an acoustic array of underwater receivers at Lower Herring Bay, Orca Inlet, and Port Gravina. The arrays will track and monitor tagged Pacific Herring and Pollock.

PROPOSED DATES OF USE: Start: February 1, 2018 End: January 31, 2023
