The Mob/Demob charges will not be accepted to Mob between projects in the same district as the initial call-out.**
- 3. Hourly rates shall be defined as Crew Rates, this includes man hours and equipment hours. For evaluation purposes please base your rates on a 60 hour work week.**
- 4. All travel, lodging, per diem, and equipment fluids shall be included in the Hourly rate, no additional charges for these services shall be accepted.**
