Question #1: Can you please identify how many oil tanks you want delivered to each site identified in the plans?

Answer #1: Approximately 378 ton to the Rezanof Drive Right of way location, and 300 ton to the DOT Shop at 1,500 Anton Larson road.

Question #2: Would the department consider adding a second delivery date for half the order of CRS-2P?

Answer #2: We would allow 2 shipments 400 ton for the first shipment by 6/10/19 and 278 ton in a second delivery on 7/8/19.
