Termination of a Public Utility Easement

This document terminates Public Utility ADL 227577 this _____ day of _____, 2020. This easement was previously granted on April 28, 2000 by the State of Alaska, acting by and through the Department of Natural Resources, Division of Mining, Land and Water, Southcentral Regional Land Office, hereinafter referred to as the Grantor, to Cordova Telephone Cooperative Inc. (CTC), hereafter referred to as Grantee. This easement was previously recorded within the Cordova Recording District as document number 2010-000190-0.

The easement document stated that the utilities telephone line is located in portions of Section 12, 13, 23, 24, 26 of Township 15 South, Range 3 West, Copper River Meridian and offered no further detailed legal description or survey information. This Right-of-Way stated that *"In case the necessity for the right-of-way shall no longer exist, or the permittee should abandon or fail to use the same, then this permit shall be revoked or terminated."* The Grantee concurs that the easement under ADL 227577 is unnecessary and should be terminated in favor of the easement created under ADL 233511.
