Questions submitted by potential offerors and answers from the State

Question 1: What the heaviest single piece of equipment or building might be on this project?

<u>Answer:</u> It is believed to be greater than 50 tons, without any of the ancillary parts. In previous sailings, the estimated weight was over 3000 tons.

<u>Question 2</u>: Curious if a company could make several trips, at its discretion, rather then just the two or three?

Answer: Timeline/scheduling for onsite contractors and personnel to provide services is too short to allow for multiple trips at the contractor's discretion.

Changes to the ITB

Change 1: This portion of Sec. 2.01 SCOPE OF WORK AND SPECIFICATIONS is deleted in its entirety:

The Contractor shall transport materials, equipment, and supplies from Ketchikan, Alaska, to Icy Cape, Alaska. Icy Cape is located approximately 70 miles northwest of Yakutat, Alaska in west Icy Bay. Because there are no docking facilities at Icy Cape, the Contractor shall use a ramp barge or landing craft which meets USCG Load Line Regulations and is capable of loading and off-loading in a remote undeveloped location.

The TLO will arrange for delivery of items to either the Alaska Marine Lines (AML) or Olson Marine in Ketchikan. The Contractor must transport items from the Ketchikan location (either AML or Olson Marine) to Icy Cape.

And is replaced with:

The Contractor shall transport materials, equipment, and supplies from Ketchikan, Alaska, to Icy Cape, Alaska. Icy Cape is located approximately 70 miles northwest of Yakutat, Alaska in west Icy Bay. Because there are no docking facilities at Icy Cape, the Contractor shall use a ramp barge with a minimum 60-foot ramp. The barge shall have a minimum 3250-ton capacity and meets USCG Load Line Regulations and is capable of loading and off-loading in a remote undeveloped location.

The TLO will arrange for delivery of items to a State project manager and Contractor agreed upon location in Ketchikan. The Contractor must be able to provide a minimum two-acres secure storage for materials, heavy equipment, 20ft, and 40ft shipping containers, and other supplies, in Ketchikan. The Contractor must be able to provide a minimum 40ft x 60ft dry indoor storage for climate sensitive items, in Ketchikan. The storage period of the materials, equipment, and supplies is unknown. The Contractor must transport items from the Ketchikan location to Icy Cape.

Change 1: ATTACHMENT 1 BID SCHEDULE is being deleted in its entirety and being replaced with:
