ITB TITLE: Air Service Charter – Dalton Highway Crew Change

REVISED ITB OPENING DATE AND TIME: February 18th, 2021 at 10:00 AM

The following changes/additions are required:

1. Change the bid opening date from February 10th, at 10:00 AM to the revised date of February 18, 2021 at 10:00 AM.
2. Change the contract period (page 7). Expected date of award shall be July 1, 2021, with the option to renew for Five (5) additional One (1) year terms under the same terms and conditions as the original contract. Renewals are to be exercised solely by the State.
3. Add the following language:
Contract Changes – Amendments: During the course of this contract, the contractor may be required to perform additional work. That work will be within the general scope of the initial contract. When additional work is required above what is considered “As Needed”, the State will provide the contractor a written description of the additional work and request the contractor to submit a firm time schedule for accomplishing the additional work and a firm price for the additional work. Cost and pricing data must be provided to justify the cost of such amendments per AS 36.30.400.

The contractor will not commence any additional work until the procurement officer has secured required State approvals necessary for the amendment and issued a written contract amendment.

4. Remove Capacity from Scope of Work and Specifications (page 9) in its entirety and replace with the following:
Capacity: Aircraft shall have the capacity to support an average of 15 passengers and shall be capable of transporting up to 20 passengers. Each passenger shall be capable of transporting up to 100 pounds of gear/luggage. It is acknowledged that with an increase in passengers the amount of gear/luggage may need to be reduced. Each passenger shall be allowed a minimum of 50 pounds of gear/luggage.

5. Remove Flight Schedule from the Scope of Work and Specifications (page 9) in its entirety and replace with the following:

Flight Schedule: The schedule day of service/travel will be Tuesdays for Galbraith Lake Airport and Thursdays for Prospect Creek Airport. Service/travel will be provided on either a weekly or bi-weekly schedule to be determined by the Department. Current operations are bi-weekly, this may change when contract is established. Any changes from bi-weekly to weekly shall be mutually accepted by the awarded contractor and the State. Mutually agreed upon changes will require thirty (30) day written notice.

6. Remove Flight Deviations from the Scope of Work and Specifications (page 10) in its entirety and replace with the following:

Flight Deviations: In the event that a flight departs from the Designation Point and are unable to land at the Destination Point, the State shall only be charged Flight Time. Please indicate charge for Flight Time on the Bid Schedule. This price is informational only and will not be evaluated.

7. Add the following language to the Scope of Work and Specifications

As Needed: The State may request for additional flights other than the scheduled days of service. Any additional flight will be mutually agreed upon and requested in writing. As much advance notice will be provided from the department, the contractor shall make every effort to fulfill these requirements when requested. Additional flights for each location have been added to the Bid Schedule, please indicate the total cost for each location.

8. Add the following language to the Scope of Work and Specifications

Weather Reports: The State will provide weather reports on the scheduled day of service/travel.

9. Remove Bid Schedule in its entirety and replace with the attached Bid Schedule per Amendment 3.
