Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Department of Health against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Department of Health after the close of the public comment period.

The regulations concern Medicaid coverage and payment for the services of a dental hygienist holding an advanced practice permit under AS 08.32.125, effective January 1, 2023 (sec. 4, ch. 56, SLA 2022 (CSSB 173(FIN) am H)); or a dental specialist under AS 08.36.242 and 08.36.243, effective July 1, 2023 (sec. 6, ch. 56, SLA 2022 (CSSB 173(FIN) am H)).

The October 12, 2023 public notice and the January 25, 2024 adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

We have made a technical correction to conform the regulations in accordance with AS 44.62.060. The correction is incorporated into the attached copy of the regulations.
