#### Dear Lieutenant Governor Dahlstrom:

The Department of Law has reviewed the attached regulations of the Board of Dental Examiners against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This letter constitutes the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations. The regulations were adopted by the Board of Dental Examiners after the close of the public comment period.

In accordance with the repeal of AS 08.36.075 under secs. 13 and 17, ch. 56, SLA 2022 (CSSB 173(FIN) am H), and the transfer of authority over dental radiological equipment from the Board of Dental Examiners to the Department of Health, the board repealed corresponding regulations regarding dental radiological equipment.

The relevant provisions of SB 173 took effect on July 1, 2023. Accordingly, we respectfully request that your office file these regulations as soon as possible.

The November 20, 2023 public notice and the February 23, 2024 certification of adoption order both state that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.060 is not required.

We have made some technical corrections to conform the regulations in accordance with AS 44.62.060. The corrections are incorporated into the attached copy of the regulations.
