PROPOSAL TO LEASE: The State of Alaska, Department of Transportation and Public Facilities, (DOT&PF) proposes to execute Supplement No.4 to Concession Agreement ADA-31935 in the North and South Terminals at the Ted Stevens Anchorage International Airport. This Supplement combines Concessionaire's two concession agreements (ADA-31935 and ADA-31788) and adds term (5 years) to the surviving agreement. **APPLICANT:** Alaska Channel, Inc **TERM:** Until March 31, 2031. **AUTHORIZED USES:** non-exclusive rights to 1) develop, construct, place, operate, maintain, and sell advertising on static displays and electronic media such as Concessionaire-provided electronic and high-tech displays, touch screen displays, column wraps, or other advertising displays 2) develop and sell advertising on State-provided and maintained electronic displays at specified locations deemed appropriate in the Airport's terminals.
