Call for Proposals (CFP) Announcement:

AKSSF is announcing its 2014 statewide CFP which will open April 15. The amount of funding available is not yet known, but is expected to be no more than \$4 million. The following partial list of conditions applies to this CFP:

- Proposals must be submitted through our website (www.akssf.org) which will contain all required forms, templates, and reference documents
- All proposals must be received by 12 p.m. (noon) Alaska Daylight Time on July 16, 2014.
- Proposals submitted by 12 p.m. (noon) Alaska Daylight time on June 17, 2014, will be provided with a courtesy administrative pre-review.
- Notification letters (i.e., funding decision letters) will be sent to applicants by December 19, 2014.
- Proponents must contribute a 35% non-federal match.
- Projects must be completed by November 30, 2017.
- Projects must directly relate to one of the following congressionally authorized uses:
 - Restoring or protecting salmon or steelhead habitat
 - Maintenance of salmon or steelhead populations necessary for subsistence fishing
- Projects must directly relate to one or more high priority objectives in their respective AKSSF region (Arctic-Yukon-Kuskokwim, Central, Southeast, or Westward; high priority objectives will be available when the call opens).
