(d) A domestic or foreign limited liability partnership that fails to file a biennial report within the time prescribed under **AS 32.06.913** [AS 32.05.590] is subject to an additional charge of 10 percent of the total amount of the filing fee, and the late charge as stated in (c) of this section.
