NOTICE OF PROPOSED CHANGES IN THE REGULATIONS OF THE ALASKA DEPARTMENT OF ENVIRONMENTAL CONSERVATION

BRIEF DESCRIPTION

The Alaska Department of Environmental Conservation proposes to change regulations dealing with Oil and Other Hazardous Substances Pollution Control. This includes revisions to update the regulations to incorporate current communications technology such as electronic mail, repeal outdated regulations, update references and provide consistency between related regulations.

The Alaska Department of Environmental Conservation proposes to adopt regulation changes in Title 75 of the Alaska Administrative Code, dealing with Oil and Other Hazardous Substances Pollution Control, including the following:

- (1) amend 18 AAC 75.215 to allow for the submittal of applications by electronic mail.
- (2) amend 18 AAC 75.225(a) to allow nontank vessel renewal applications to be submitted 15 days before the expiration.
- (3) amend 18 AAC 75.235(n)(3) to update the citation references for plugged and abandoned wells.
- (4) amend 18 AAC 75.240(b) to allow for the use of electronically mailed certificates.
- (5) amend 18 AAC 75.300(a) to allow for the use of electronic mail.
- (6) repeal 18 AAC 75.413, because the 2002 transition deadlines have passed.
- (7) repeal 18 AAC 75.443, credits for nontank vessel plans because they are no longer necessary to extend the approval period from three years to five because prevention plans are now valid for five years.
- (8) amend 18 AAC 75.456(b) and 460(d) to update the effective period for plan approvals from three years to five.
- (9) repeal 18 AAC 75.456(b)(3) and 460(d)(3), which refer to 18 AAC 75.443 which is being repealed.
- (10) amend 18 AAC 75.459(a) to indicate that department offices are no longer referred to as regional offices.
- (11) amend 18 AAC 75.475(b) to allow notifications to be provided by electronic mail and to indicate that department offices are no longer referred to as regional offices.
- (12) repeal 18 AAC 75.521(c), 522(c), and 523(c) because the 2002 transition deadlines have passed.
- (13) amend 18 AAC 75.990(151)(A) and (B) to correct outdated references.




