Committee Substitute for Senate Bill 2 am, is before me. The bill bears similarity to proposals vetoed by previous governors. But its provisions do avoid several difficult problems presented in earlier attempts to create a Bristol Bay reserve.

In contrast to earlier proposals, the boundaries of the reserve in this legislation do not include any presently leased tracts of State tidelands. Therefore, earlier constitutional problems that would likely have required substantial compensation payments to lessees within the reserve, have been eliminated.

The bill does not shut out tidelands oil and gas development within the reserve. Slant-drilling from onshore locations would not be affected, but a legislative resolution would be required in approving issuance of a direct surface entry permit for developing any proposed oil and gas leases within this reserve.

I would ordinarily be extremely reluctant to accept the sort of legislative usurpation of administrative function represented in the subject legislation.

However, the Bristol Bay red salmon runs are a massive and uniquely valuable renewable resource. The practical requirements of drift gill-net fishing which constitutes the most prevalent type of gear in the Bristol Bay area, could very well pose an almost impossible to overcome problem of incompatability with major offshore structures. as offshore structures are presently constituted. The problem in the major Bristol Bay fishing area is quite different than it is in Cook Inlet. Many hundreds of small vessels drift with the wind and current, which in itself poses abnormal hazards for life and equipment. Fixed obstructions in areas where such a large number of small vessels and people are involved in pursuit of livelihood, could very well increase the percentage of fisherman fatality and injury. One simply must have had opportunity to witness the situation at the peak of the run in the Bristol Bay fishing area to fathom the hazards already involved under such conditions. Being personally familiar with the circumstances at the annual peak of the Bristol Bay red salmon fishing, I am hesitant to try and second guess the almost unanimous judgment of the membership in both houses of the Alaska legislature. Therefore, I cannot find too unacceptable the notion of a limited fisheries reserve in Northern Bristol Bay.

It might be pointed out that some of the experts in petroleum development do not feel that the State tidelands involved in this bill rate too high as substantial discovery prospects. The better prospects from a geological potential standpoint, apparently lie to the south of the limited reserve proposed in this bill.

I have concluded that no evidence has been made available to indicate that Committee Substitute for Senate Bill 2 am, can possibly cause irrevocable harm to the best interests of Alaska's people.

In consideration of the above noted observations, I ampermitting the legislation to become law without ${\tt my}$ signature.
