- 1. Recognize that Section 4.03, Management Plan, Contractor Duties, item g. located on page 27 shall be deleted in its entirety and replaced with the following:
 - g. The contractor shall conduct a Physical Agility Test (PAT) with pass / fail results to be submitted along with the security officer's résumé, security officer's license, etc. The contractor shall be required to conduct annual recertification PATs on each security officer assigned to this contract. Should a security officer who has previously passed and is already assigned to this contract fail, he / she will be removed from this contract immediately until he / she can recertify with a passing score (See Exhibit E).

Should a female Officer who is due a PAT become pregnant, the decision for whether this Officer is capable to take the PAT and the decision on whether or not this Officer is fit for duty shall be up to the Officer's medical provider. It shall also be the decision of this female Officer's medical provider to determine when this Officer may take the PAT and for when this Officer is capable to return to duty after having said child. In both instances above, the State shall require written documentation on whether this female Officer is fully capable of or cannot perform the duties as described in the Contract, RFP and Post Orders.

- 2. Recognize that Section 4.03, Management Plan, Contractor Duties, item o. located on page 28 shall be deleted in its entirety and replaced with the following:
 - o. The contractor shall conduct an unannounced twelve (12) panel urinalysis drug screening of all Security Officers and the Contract Project Managers whom are assigned to this contract annually. This annual urinalysis shall be conducted by a

third party provider. Upon receipt of the results, the contracting agency shall provide proof of passage to the DGS Contracting Officer. All drug testing shall be at the sole expense of the contracting agency. The State of Alaska reserves the right to instruct the contracting company of when these drug screenings shall be conducted. All Security Officers and Contract Project Managers shall have seventy-two (72) hours to be tested once requested by the State of Alaska.

The State of Alaska reserves the right to request security officers be drug tested via twelve (12) panel urinalysis by a third party provider at any time during the contract term. Should the State of Alaska request this drug testing, the contractor agency has twenty four (24) hours from the time of the request to have the security officer tested. Test results must be submitted to the DGS Contracting Officer as soon as they become available. Security Officers are allowed to remain on the contract and work their scheduled posts until the results of the tests are received.

All Security Officers assigned to this contract must pass a twelve (12) panel urinalysis drug screening conducted by a third party provider and test results shall be provided to the DGS Contracting Officer prior to being allowed to work on site.

- 3. Recognize that the following has been added to Section 4.03, Management Plan, Contractor Duties, as item r:
 - r. Recognize that all Security Officers assigned to this contract may not carry or utilize physical self-defense equipment or tools while on duty.
- 4. Recognize that the following has been added to Section 4.03, Management Plan, Contractor Duties, as item s:
 - s. Recognize that the Surveillance Officer shall be required to man the security desk at all times during his or her shift. If an emergency situation arises, the Surveillance Officer may leave the desk if needed to assist with the emergency. The Surveillance Officer shall then return to his / her post when the situation is resolved or local law enforcement arrives.

All other terms and conditions shall remain the same.

In order for your proposal to be considered responsive, this amendment, in addition to your original proposal, must be received by the issuing office of the Division of General Services prior to the time set for the RFP opening.
