THE REGULATORY COMMISSION OF ALASKA

The attached 1 page of regulations, dealing with demand charge billing, 3 AAC 52.462 and 3 AAC 52.500, is certified to be a correct copy of the regulation changes that the Regulatory Commission of Alaska adopted at its May 28, 2014, public meeting, under the authority of AS 42.05.151, AS 42.05.141, AS 42.05.381, AS 42.05.391 and after compliance with the Administrative Procedure Act (AS 44.62), specifically including notice under AS 44.62.190 and AS 44.62.200 and opportunity for public comment under AS 44.62.210.

This action is not expected to require an increased appropriation.


On the record, in considering public comments, the Regulatory Commission of Alaska paid special attention to the cost to private persons of the regulatory action being taken.



Register 212, January ²⁰¹⁵ 2014 COMMERCE, COMMUNITY, AND EC. DEV.

3 AAC 52 is amended by adding a new section to read:

3 AAC 52.462. Demand Charge Billings. A utility may not calculate demand charge billings for any self-generating customer based upon that customer's demand as measured during forced outages of customer generation facilities required to resynchronize and return the customer's self-generation output to parallel operation with the utility during the one-hour period after power to the self-generating customer is restored following a utility system outage that originates on the utility's side of its metering to the customer affecting service to the self-generating customer. 3 AAC 52.500 is amended by adding a new ^{paragraph} subsection to read:

(32) "self-generating customer" means a retail electric customer capable of generating some or all of its power requirements using electric generation equipment interconnected with the electric utility's plant in a manner that allows parallel operation.
