- Q. Can you give us a sense of priority with regard to the campaign's target audiences?
- A. This is not a campaign and there will be different target audiences depending on the project assigned through the task order system.
- Q. If you had to divide the resources between reaching and influencing out-of-state audiences vs. in-state audiences, what percentage of resources should be allocated to out-of-state versus in-state audiences?
- A. There are no specific projects and the audience will be determined depending on the project through the task order system.
