The following changes are required:

1. Delete item 12, Jacket, Military-Style, M65 Storm Jacket from the Specifications and Bid Schedule.
2. Replace item 12 in the specifications with:

12. Jacket, Military-Style, M65 Field with Liner: MIL-SPEC, poly or nylon/cotton twill (50% cotton/50% polyester or nylon), concealed hood, four large snap-up cargo pockets, removable button-in liner, Velcro wrist cuffs, waist, hood, and bottom drawstrings, snap up storm flap, heavy brass zipper, water and wind resistant. Sizes: Men's Small through 5XL (regular lengths). Color: Black. Style: Propper F5420, Rothco 8445, or State approved equivalent. **SUPPORTING INFORMATION REQUIRED.** Estimated annual usage: 50 each (40 sizes small through XL and 10 sizes 2XL through 5XL).

3. Replace item 12 on the bid schedule with:

12. Jacket, Military-Style, M65 Field with Liner, as specified:

a. Sizes Small through XL: Estimated 40 each x \$ _____ unit cost = \$ _____ extended cost.

b. Sizes 2XL through 5XL: Estimated 10 each x \$ _____ unit cost = \$ _____ extended cost.

c. **Total Purchase Cost for Items 12a and 12b:** \$ _____.
