Notice is given that the Department of Community and Economic Development, Division of Occupational Licensing, under the authority of the Alaska Constitution, Article 1, Sec. 22, AS 08.01.050, AS 08.01.080, AS 08.01.087, and AS 08.01.100, proposes to amend and adopt regulations in Title 12 of the Alaska Administrative Code dealing with continuing education and confidential records, to implement, interpret, and make specific Alaska Constitution, Article 1, Sec. 22, AS 08.01.050, AS 08.01.080, AS 08.01.087, and AS 08.01.100, including:

1. 12 AAC 02.965, FAILURE TO MEET CONTINUING EDUCATION REQUIREMENTS, is a proposed new section that deals with failing to meet continuing education requirements.
2. 12 AAC 02.970, CONFIDENTIAL RECORDS, is a proposed new section that defines what records are considered confidential and may not be released to the public.

The Milne Point Pipeline Company proposes to construct a common carrier pipeline to transport natural gas liquids. The pipeline will originate in the Kuparuk River Unit south of the Spine Road/Milne Point Road intersection within Section 8 of Township 11 North, Range 11 East of the Umiat Meridian, thence in a northerly direction, above ground on existing vertical support members (VSMs) to terminate in the Milne Point Unit at the Central Facilities Pad within Section 27 of Township 13 North, Range 10 East of the Umiat Meridian. A metering station is planned to be located at the Central Facilities Pad. Installation of the pipeline will occur

from existing facilities and an ice road.

The proposed 8-inch diameter pipeline is approximately 10.4 miles long. The pipeline will handle a future potential flow rate of up to 18,000 barrels per day. The pipeline has a minimum estimated service life of 30 years.

The pipeline project is located on state lands. Proposed construction is planned to begin in January 2001 with project completion in February 2001. Construction will be performed only during the winter months. No gravel placement is required.
