Notice is given that the Regulatory Commission of Alaska, under the authority of AS 42.04.080, AS 42.05.141, AS 42.05.151, and AS 42.06.140 proposes to adopt changes in its regulations in Title 3 of the Alaska Administrative Code, dealing with motions practice before the Commission, as follows:

3 ACC 48.191 is proposed to be added to set out procedures that govern the filing of motions and related documents with the Commission. The provisions of the section are, for the most part, based on those portions of the Alaska Rules of Court, Civil Rule 77, Motions, which the Commission has adopted for use on a case-by-case basis in proceedings where rules governing such have been necessary.

The proposed regulation specifies the filing, service, and general pleading requirements for motions and related pleadings; sets out timelines for filings in opposition to a motion, for reply to such opposition, and the period of time before which the Commission will take action on a motion. The proposed regulation also sets out procedures regarding motions for expedited consideration; use of stipulations in support of motions; consequences of frivolous motions or oppositions thereto; supplemental authority citations; and use of motions in discovery disputes.

Notice is also given that any person interested may present written statements relevant to the proposed action, including the potential costs to private persons of complying with the proposed action, by writing to the Regulatory Commission of Alaska, 1016 West Sixth Avenue, Suite 400, Anchorage, Alaska 99501, so that comments are received by 4 p.m., October 31, 1999. Additionally, any interested person may present oral or written statements or arguments relevant to the proposed action at a public hearing to be held at 8:30 a.m., November 9, 1999, in the Commission's hearing room, 1016 West Sixth Avenue, Suite 305, Anchorage, Alaska, to consider comments on the proposed regulation amendment.
