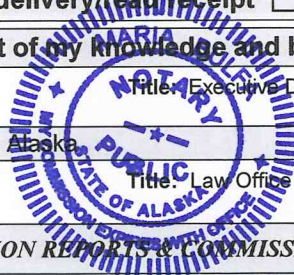

RE: Your Future Alaska and Alaskans First's Violations of AS 15.13 Campaign Disclosure Laws

I. BACKGROUND

During the summer of 2014, Marcia Davis, April Ferguson, and Vicki Otte formed two domestic nonprofit corporations: Your Future Alaska ("YFA") and Alaskans First ("AF").¹ According to their Articles of Incorporation, the corporations were "organized exclusively for the purpose of influencing elections and related purposes" and exist for the stated purpose of influencing "the selection, nomination, election, or appointment of any individual to any federal, state, or local public office."² Both corporations were formed as tax-exempt political organizations in accordance with 26 U.S.C. § 527.³

During the 2014 State General Election period the corporations collected contributions and made expenditures to influence the outcome of the election and were required to disclose their activity.⁴ Staff now files this complaint and believes the facts will show that each entity violated provisions of campaign disclosure law.

II. ALLEGED VIOLATIONS

A. Failure to Timely Disclose Contributions and Expenditures

YFA and AF failed to timely disclose their financial activity. Persons that participate in election activities are required to file a full report of expenditures made and contributions received.⁵ The report must be filed no later than ten days after an expenditure is made, or if made within the nine days prior to the election, within 24 hours.⁶

Leading into the election, YFA made \$71,000 in expenditures in the form of contributions to other persons.⁷ However, YFA did not disclose those expenditures until

November 24, 2014 – 20 days after the election.⁸ Additionally, only after staff inquired in earnest about its sources of funding, did YFA amend their filing to disclose their contributors – 330 days after the election.⁹

AF spent in excess of \$30,000 leading into the election.¹⁰ Unlike YFA, AF did disclose its expenditures prior to the election.¹¹ However, their first attempt to disclose their contributors was on December 31, 2014 – 57 days post-election.¹² Both YFA and AF failed to timely disclose their financial activity in violation of AS 15.13.040 and AS 15.13.110.

B. Failure to Identify True Source of Funds

YFA acted as a pass through for other persons to make unidentified contributions. Contributions must be identified by the true source of money.¹³ Here, it appears YFA’s only purpose during the 2014 general election was to “sanitize” money collected from donors, by contributing the money to two other persons, in its own name.

YFA contributed \$21,000 to AF, a registered entity, sharing the exact same officers and directors as YFA.¹⁴ And YFA contributed \$50,000 to Walker Mallot 1, a registered independent expenditure group whose Treasurer, Vicki Otte, was also a Director and Vice President of both YFA and AF.¹⁵ Using a third-party conduit to hide the true source of money violates provisions of AS 15.13.074(b) and 2 AAC 50.258.

C. Failure to Register Prior to Making Expenditure

YFA failed to register prior to making its first expenditures. All persons must register with the Commission prior to making an expenditure.¹⁶ YFA registered as an entity on October 28, 2014.¹⁷ However, they had already made two expenditures. First, on October 22, 2014, when they contributed \$7,000 to AF.¹⁸ Second, on October 25, 2014, when they contributed \$50,000 to Walker Mallott 1.¹⁹ YFA violated AS 15.13.050 when they made expenditures prior to registering with the Commission.
