Complaint against Open for Business with Bronson (renamed Open for Business Anchorage)

This complaint alleges that the **Open for Business with Bronson IE** (initial APOC registration name) and / or **Open for Business Anchorage IE** (renamed on 6/30/21) have committed the following violations:

- Late filing of a 10 Day Report
- Failure to file other required 10 Day IE reports
- Made an expenditure before registering (Open for Business Anchorage)
- Failure to file a 24 Hour Report
- Incorrect Donor information / Missing Donor?

10 Day IE Report filed 5/20/21 - Attachment A (pages 1-2)

The Open for Business with Bronson (OFBWB) / Open for Business Anchorage (OFBA) has filed just one 10 Day IE Report.

- The IE report contained two expenditures:
 - 5/5/21 for Optima Public Relations for \$25,000 for text campaign, newspaper placement
 - 5/11/21 entry for Optima Public Relations for \$7500 for newspaper ad creation and placement
- The 5/5/21 entry for Optima Public Relations was filed 15 days after the date reported which makes it **5 days late**. The 5/5/21 date puts it in the 24 hour reporting cycle but no 24 hour report was filed. **Attachment A, pg 1.**
- The 5/11/21 entry for Optima Public Relations is likely the date the expenditure was paid and not the date it was incurred. (Since 5/11/21 was the date of the Mayoral Runoff election, it is likely that the ad creation and placement occurred before that date. If so, the reporting of that entry is also late.) **See Attachment A, pg 2**
- This 10 Day IE Report – the only 10 Day IE Report filed - **did not report any income. See Attachment A, pg 2**, although the 7 Day and 105 Day Reports show thousands of dollars in contributions were received.

7 Day Runoff Report filed 5/4/21 - Attachment B (pages 1-3)

- The report showed \$43,750 in income, none of which has been reported on a 10 Day IE Report. **Attachment B, pgs 1-2**
- The report showed \$ 29,570 in expenditures, including \$9200 in non-monetary items and \$20,370 to Optima Public Relations for radio ad production and placement. **See Attachment B, pg 3.** None has been reported on a 10 Day IE Report.

105 Day Report filed 8/24/21 - Attachment C (pages 1-4)

- The report showed income of \$39,700, none of which has been reported on a 10 Day IE Report. **See Attachment C, pgs 1-3.**
- The report showed \$47,963.56 in expenditures of which only the 5/5/21 entry to Optima Public Relations for \$25,000 was on a 10 Day IE Report. **See Attachment C, pgs 3 -4.**
- An expenditure entry dated 5/10/21 to Optima Public Relations for \$13,400 occurred during the 24 Hour Reporting cycle but no 24 Hour IE Report was filed nor was it listed on a 10 Day IE Report. **See Attachment C, pg 3.**

Expenditure before Registration

The IE group **Open for Business with Bronson** changed its name to **Open for Business Anchorage** on **6/30/2021**. See **Attachment D**. Domain registration records show that **openforbusinessanchorage.org** was purchased **6/10/2021** (see **Attachment E**), 20 days before the group **Open for Business Anchorage** was registered which is a violation.

24 Hour True Sources Report filed 5/4/2021 – Attachment F (pgs 1-2)

- The report shows a 5/3/21 contribution from **WEKA, LLC for \$2000 (check #3755)**. See **Attachment F, pg 2**.
- However, the 105 Day Report does not show a contribution from WEKA, LLC on 5/3/21. See **Attachment C**. Instead there is a contribution from **WEKA Tactical for \$2000 (check #188731)**.
- A search of Alaska Business Licenses indicates that **WEKA, LLC and WEKA Tactical are two distinct businesses**. See **Attachment G, pgs 1-2**. Did each give \$2000? If so, only one was listed on a 24 Hour Report. If only one gave \$2000, how did the name of the other business make its way onto the 105 Day Report?

Other issues surround 5/3/21 donors on the True Sources Report vs the 105 Day Report. Below is information for some 5/3/21 contributions. (105 Day entries are in **bold**.)

- Note the check number differences for contributions made by the same donor (highlighted below).
- There are four distinct donors (Crystal Herring; Tactical, LLC; Nutrition Express, LLC; TC Leasing, LLC) are all listed at the same address.
- Business licenses for Nutrition Express, LLC and TC Leasing, LLC show the same address – but different from what is listed below. The business licenses show **PO Box 240474, Anchorage, AK 99524**. WEKA, LLC (on the 24 Hr Report but not the 105 Day report) is also listed at PO Box 240474. (**Attachment G, pgs 2-4**). I could not find a license for “Tactical LLC”.

- A search of the APOC database shows that Crystal Herring’s address is 2501 Winterchase Circle, Anchorage 99516.
- An internet search shows that **PO Box 244027, Anchorage, AK 99524** belongs to **Hilcorp Alaska**. See **Attachment H**. Did Hilcorp Alaska contribute to Open for Business with Bronson on 5/3/21? If so, why wasn’t its name reported? If Hilcorp Alaska did not contribute, how did its address end up being associated with these other donors?
