ORDER DENYING REQUEST FOR EXPEDITED CONSIDERATION

Virginia Bonnie Lembo alleges that an independent expenditure group, Friends of District 17 Opposed to Zack Fields, illegally coordinated with candidate Harriet Drummond and failed to timely disclose contributions and expenditures. Ms. Lembo asked the Alaska Public Offices Commission to hear her complaint on an expedited basis.¹ On September 16, 2022, the Commission considered her request and denied expedited consideration after hearing testimony from Ms. Lembo and the group.²

The Commission denied expedited consideration because the group acknowledged that reporting and organizational violations occurred³ and planned to dissolve the group,

not engage in any elections activity, and return the contributions.⁴ Thus, although there is "reasonable cause to believe that . . . violation[s] ha[ve] occurred," Ms. Lembo did not establish that the alleged violations, "if not immediately restrained, could materially affect the outcome of an election" or "could cause irreparable harm that penalties could not adequately remedy."⁵ Ms. Lembo agreed that dissolution of the group would resolve the need for an urgent resolution.

The Commission accepts the complaint for consideration on a regular basis under AS 15.13.380(e) and refers the complaint to staff for investigation.
