This document is to add the following to my officially sworn two-page summary attached to APOC Case Number 24-02-CD, *Goforth v Friends of the Palmer Public Library*.(Copy attached)

Without notification, it appears an event resembling an involuntary Corporation Dissolution took place on or about June 16, 2024 concerning my officially registered corporation FRIENDS OF THE PALMER LIBRARY. Documentation for the existence of Entity #10266759 no longer exists with the State of Alaska Department of Commerce, Community, and Economic Development – Division of Corporations, Business and Professional Licensing, despite the inclusion of a copy of the original document in APOC Case #24-02-CD as Exhibit 1.

The desire to advocate for Palmer Public Library in order to (quote gleaned from Chief Justice Rehnquist opinion #204 of *United States v. American Library Association, Inc. 2003*): provide materials "that would be of greatest direct benefit or interest to the community", and collect only those materials deemed to have "requisite and appropriate quality.". That is the purpose FRIENDS OF THE PALMER LIBRARY Entity #10266759 was established and registered with Alaska State DCCED on April 14, 2024.

That desire still exists, which is why I registered a new nonprofit corporation today for the same purpose. It is PALMER FRIENDS. The Entity Number is 10277137. (Copy attached)

My position as President of the previously existent Corporation FRIENDS OF THE PALMER LIBRARY, Entity #10266759, was the opening statement in my original summary attached to APOC Complaint 24-02-CD. It was listed merely to demonstrate the catalyst behind *how* substantive evidence was discovered; *it is not – and never was - the reason for the APOC complaint*.

Using a non-existent corporate name to conduct business is not within the parameters of the Alaska Public Offices Commission. (That is a violation of 12 AAC 12.020(a)(g) through consumer affairs division of Alaska State Attorney General's Office.)

APOC Case No 24-02-CD contains evidence that PALMER FRIENDS OF THE PUBLIC LIBRARY, INC. violated State of Alaska Campaign Disclosure Laws AS 15.13, 2 AAC 50.250-405 when they physically conducted a hidden campaign in fall of 2023 not only using a fictitious name, but failing to report donations, expenditures, donors, bank information, et al.
