SUBJECT: Staff Report, Complaint 24-06-CD, *Donald Handeland v. Kelly Merrick*

SUMMARY OF COMPLAINT

Donald Handeland (Complainant) alleges that the campaign of Sen. Kelly Merrick (Respondent, the candidate, or Sen. Merrick) violated three campaign finance disclosure laws. Sen. Merrick's campaign held a picnic at a privately owned park in Eagle River, AK. At the picnic, they served salmon fillets, which were donated by an out-of-state LLC. They also advertised the picnic as having a fire engine, which a local firefighters' union supplied.

The Complainant alleges that the salmon was a prohibited contribution to the Respondent from a business entity; the Respondent failed to report the in-kind contribution of the fire engine, which in turn exceeded the limits for contributions by a political action committee (PAC); and the Respondent failed to report expenditures related to the rental of the park for a campaign event.¹

SUMMARY OF ANSWERS TO COMPLAINT

The Respondent acknowledges that the campaign had inadvertently accepted an inkind contribution from a business, mistakenly believing it had originated from an employee PAC; the Respondent further advises that they have reimbursed the value of the contribution to the business entity. The Respondent also states that there was no contribution to the campaign that exceeded the maximum allowable limit for a PAC, nor

did the campaign fail to report expenditures in regard to a campaign event, as no expenses were incurred.²

FACTS

Sen. Merrick is campaigning for re-election to the State Senate in the 2024 state election. In her 30 Day General Campaign Disclosure Report, filed on October 7, 2024, she disclosed a September 12, 2024, contribution from Firefighters Local 1264 PAC in the amount of \$1,000 and an in-kind contribution of 25 pounds of sockeye salmon received on September 25, 2024, from OBI Seafoods valued at \$218.75.³

Sen. Merrick held a community picnic and campaign fundraising event on September 28, 2024, at the Eagle River Lions Park.⁴ This event was publicized through campaign mailers as well as on the candidate's Facebook page.⁵ The Facebook event page specifically marketed the event has having "food, fun, and a FIRE TRUCK!" A subsequent Facebook posting on September 29, 2024, included images of the candidate and other unidentified individuals attired in campaign-branded clothing. These images show these individuals posing with packaged salmon from OBI Seafoods and next to a fire engine bearing the logo of the International Association of Firefighters Local 1264.⁷ Accompanying these images is a post from Sen. Merrick expressing appreciation to OBI Seafoods for their donation.

OBI Seafoods, LLC is a business entity registered as a limited liability company (LLC) in the state of Washington.⁸ After the complaint was filed, the campaign contacted OBI Seafoods and learned that the in-kind contribution of salmon did not come from an

employee PAC but rather was donated by the LLC.⁹ Sen. Merrick's campaign then paid OBI Seafoods for the cost of the salmon.

Additionally, Sen. Merrick's campaign was not charged for the use of Eagle River Lions Park or to have the fire engine at the event. The President of the Eagle River Lions Club submitted a statement explaining that the club's park "has been and will always be, with just a very few exceptions, free to the public for their use and enjoyment on a first come, first serve basis." The Vice President of the Firefighters Local 1264 submitted a statement that the "union fire engine is a free service [the union] provide[s] for community events."

LAW AND ANALYSIS

1. The Respondent violated AS 15.13.074(f) by accepting a prohibited contribution and not returning it within 10 days.

Unless it satisfies the definition of a group or nongroup entity under AS 15.13.400, a company is statutorily prohibited from making contributions to a candidate. Here, the candidate received an in-kind contribution of salmon from OBI Seafoods, LLC (which is not a group or nongroup entity) for a campaign event. A candidate that receives a prohibited contribution must return such contributions to the contributor immediately, but not later than 10 days after receipt. Once aware that the contribution was prohibited, Ms. Merrick reimbursed OBI Seafoods, LLC in the amount of the contribution on October 21, 2024, and disclosed the reimbursement on her 7 Day Campaign Disclosure Report.

2. The Respondent did not receive contributions from the Firefighters Local 1264 PAC in excess of the allowable amount. Moreover, we do not have sufficient evidence to conclude that the Respondent violated AS 15.13.074(f) by accepting a prohibited contribution from a labor union.

The Firefighters Local 1264 provided a fire engine at Sen. Merrick's September 28, 2024 community picnic and fundraising event. Sen. Merrick's campaign used the fire engine as a marketing attraction to generate support for her campaign event, writing on the Facebook event page to join for "food, fun, and a FIRE TRUCK!" Because this union's PAC had previously contributed the maximum allowable amount of \$1,000, the Complainant alleges the presence of the fire engine constitutes an additional in-kind contribution in excess of the allowable contribution limit. 15

The Complainant is incorrect that the fire engine was an in-kind contribution from the Firefighters Local 1264 PAC. Instead, the statement submitted by the union's Vice President refers to the fire engine as property of the union itself. ¹⁶ Because the alleged contribution did not come from the Firefighters Local 1264 PAC, the PAC did not make contributions to the Respondent in excess of the maximum allowable amount.

However, this does pose another issue—whether providing the fire engine for free as an attraction to induce prospective voters to attend the Respondent's campaign event is a "contribution" for purposes of Alaska's campaign disclosure laws. Under AS 15.13.074(f), a "labor union . . . may not make a contribution to a candidate." So, if providing the fire engine is a contribution, then the Respondent accepted a prohibited contribution in violation of AS 15.13.074(f).

A "contribution" is defined in relevant part as [1] the "gift of . . . services for which charge is ordinarily made . . . [2] that is rendered to the candidate . . . and [3] that is made for the for the purpose of . . . influencing the nomination or election of a candidate." Here, we believe that the second and third prongs have been met. The service of providing the fire engine at a campaign event as an attraction and marketing tool is a service that was rendered to the candidate for the purpose of influencing her election. In our minds, the

closer question is whether this was a gift of services for which charge is ordinarily made. The statute is ambiguous as to *who* ordinarily charges for the services. On the one hand, the union does not charge to use its fire engine for community events. But on the other hand, renting a vehicle or marketing attraction is a service for which renters ordinarily charge.

In our view, the ambiguity should be resolved in favor of classifying this service as a contribution. We reach this conclusion for two reasons. First, there is the regulatory definition of "contribution." Under 2 AAC 50.990(7)(c)(vii), the "provision of a service . . . to a candidate" is not a contribution if (a) the candidate pays entity providing the service a commercially reasonable rate, or (b) "the entity providing the service . . . makes the service . . . available to all candidates for a particular office." This latter provision would be superfluous if entities could simply choose not to charge for a particular service and offer it only to the candidates they support. That is, if the statutory definition of "contribution" in AS 15.13.400(4)(A)(i) already made clear that an entity can offer a service free of charge and only make it available to the candidates the entity supports, then the regulatory clarification would be unnecessary.

Second, and more broadly, Alaska's campaign finance disclosure laws must, as with all Alaska laws, be interpreted "according to reason, practicality, and common sense, taking into account the plain meaning and purpose of the law as well as the intent of the drafters." The campaign finance disclosure laws are aimed at "deter[ring] actual corruption and avoid[ing] the appearance of corruption." Consistent with that principle, the State (like the federal government) has long restricted corporations and labor unions from directly contributing to candidates as part of guarding against the risk of quid-pro-

quo corruption arrangements.²² Even if we think the use of a fire engine at a local campaign event is largely harmless, the bigger picture is the problem: to allow an entity to make an end-run around the contribution restriction in AS 15.13.074(f) by offering the use of its own possessions only to candidates the entity supports would create a loophole that could be exploited.

So, in our view, to determine whether the union allowing the use of its fire engine is a prohibited contribution in violation of AS 15.13.074(f), the dispositive question is not whether the union normally charges for the use of its fire engine. The question is whether the union "makes the service . . . available to all candidates for a particular office." ²³

Here, while we strongly suspect that the union would not have offered its fire engine for free to a candidate that the union did not endorse, the evidentiary record does not support that finding. Put directly, the Complainant did not allege that the union restricted its services related to the fire engine, and the Respondent presented evidence that the "union fire engine is a free service [the union] provide[s] for community events," and the union has "never charged anyone to use it in the past." In light of that evidentiary record, we cannot conclude that the Respondent violated AS 15.13.074(f) by accepting a prohibited contribution from a labor union.

3. The Respondent was not required to report any expenditure or contribution relating to her use of a park for a campaign event.

The September 28, 2024, campaign event was held at the Eagle River Lions Park. According to the president of the Eagle River Lions Club, the park is made available to the public without charge on a first come, first served basis as a service to the community.²⁴ The provision of a facility for a campaign event is not a contribution if the entity providing the facility is paid a commercially reasonable rate or if the facility is made available to all

candidates for a particular office.²⁵ Here, the park is free to the general public on a first come, first serve basis. Accordingly, use of the park for the campaign event did not result in a contribution to the campaign and it did not require an expenditure from the campaign.

CONCLUSION

The Respondent accepted a prohibited contribution and failed to return it within the 10-day timeframe, constituting a violation of AS 15.13.074(f). There is no evidence to establish that the respondent either received an in-kind donation that, in conjunction with a prior contribution, exceed the permissible maximum amount or failed to disclose expenditures related to a campaign fundraising event.

MAXIMUM CIVIL PENALTIES

The maximum civil penalty for receiving and failing to timely return a prohibited contribution is \$50 per day for each day the violation continues.²⁶ For purposes of calculating the maximum civil penalties, the accrual of penalties began the day after the 10-day window for the return of the impermissible contribution expired (October 6, 2024) and was tolled on October 9, 2024, the date the Complaint was filed. The computed maximum penalty amount for the violation is \$150.

MITIGATION AND RECOMMENDATION

When staff assesses a penalty, the starting point for calculating the penalty is 2 AAC 50.855. Here, because the Respondent had been a candidate in prior elections and also had previous late filings, staff finds no applicable reductions.²⁷

A civil penalty may be reduced by a percentage greater than 50% or waived entirely if the penalty is significantly out of proportion to the degree of harm suffered by the public.²⁸ A civil penalty is significantly out of proportion if it exceeds the value of the

transactions that were reported late; here, as the value of the information exceeds the penalty amount, no reduction is warranted.

This results in a penalty of \$150 for receiving and failing to timely return the prohibited contribution violation; staff further recommends that the allegations regarding exceeding permissible political action committee reportable amounts and failing to disclose campaign expenditures be dismissed.

Background

On September 28, 2024, Senator Kelly Merrick's campaign held a campaign fundraiser at Eagle River Lion's Park. This event was posted and advertised on Senator Kelly Merrick's campaign Facebook. It included a "Paid for by Kelly Merrick for State Senate" disclosure. Other groups were listed, such as the Anchorage Police Department Employees Association, the Public Safety Employees Association Local 803, and the Anchorage Firefighters Union Local 1264. These organizations didn't report any financial expenditures or in-kind donations related to this event. These organizations also didn't post about the event on their social media pages. This was a campaign event for Senator Kelly Merrick.

Section 15.13.074 - Prohibited contributions

On September 29, 2024, Senator Kelly Merrick's campaign posed on Facebook, thanking OBI Seafoods for their "generous donation of salmon fillets." OBI Seafoods is a limited-liability company in Seattle, Washington. In the campaign's 2024 Thirty Day Report filed on October 7, 2024, filed by the candidate, \$218.75 was reported as an in-kind donation from OBI Seafoods. AS 15.13.074(f) prohibits a candidate from accepting a contribution from a company. Pictures from the fundraiser posted by the campaign on Facebook show the candidate, the donated fish, and individuals with campaign aprons on.

Section 15.13.070 - Limitations on amount of political contributions

Even though it was called a "Fundraiser & Community Picnic" this was a campaign event. The description of the event on the facebook event page was "Join us to help re-elect Kelly Merrick to the State Senate! We'll have food, fun, and a FIRE TRUCK! This family friendly event is free and open to the public. Come meet Kelly and see why she's Chugiak-Eagle River's choice for State Senate!" The candidate and other individuals adorned with campaign materials stand in front of a Firefighters Local 1264 fire truck. On September 12th, 2024, the campaign had received a \$1000 donation from Firefighters Local 1264. AS 15.13.070(c) prohibits a group from contributing more than \$1,000 per year to a candidate. The use of the firetruck at a campaign event should have been recorded as an in-kind donation to Senator Kelly Merrick's campaign and would have put that donation over the limit.

Section 15.13.040 - Contributions, expenditures, and supplying of services to be reported

The campaign event was hosted at the Eagle River Lion's Park. The park and Clubhouse belong to the Eagle River Lions Club and are rented for events. Nothing in the campaign's 2024 Thirty Day Report filed on October 7 indicates that they paid for the use of the park. Either it wasn't reported, or it was a contribution in violation of AS 15.13.074.



Please consider this letter a response to Complaint 24-06-CD. I appreciate the opportunity to clarify the issues brought to the Commission by Complainant Handeland.

I received your letter delivered via certified mail on October 21, 2024. At 4:04 PM that afternoon, I called and spoke with you about the complaint and what steps should be taken to respond. This follows that conversation.

Background

My campaign, Kelly Merrick for State Senate, held a fundraiser and community picnic on September 28, 2024, at Lions Park in Eagle River. This event was paid for using campaign funds. The invitation to the event was posted on my campaign Facebook page. It included the verbiage "Please join the Anchorage Police Department Association, Public Safety Employees Association Local 803, and the Anchorage Firefighters Union Local 1264 for a Fundraiser & Community Picnic with Senator Kelly Merrick. Saturday, September 28th, 12-3PM at Eagle River Lions Park." The disclosure "Paid for by Kelly Merrick for State Senate PO Box 776731, Eagle River, AK 99577" was included on the graphic. None of the organizations listed provided financial or in-kind donations to the event.

Once opened, the event page included "Join us to help re-elect Kelly Merrick to the State Senate! We'll have food, fun, and a FIRE TRUCK! This family friendly event is free and open to the public. Come meet Kelly and see why she's Chugiak-Eagle River's choice for State Senate!" in the description.





The purpose of the event was to raise campaign funds and to provide an opportunity for residents to meet the candidate and ask questions. It was free to the public and no attendees were turned away.

Complaint - Section 15.13.074 - Prohibited contributions

When a representative of OBI Seafoods learned about the fundraiser & community picnic, an in-kind donation of salmon fillets was provided for the event. The campaign understood this to be an in-kind donation to from the OBI Employee Political Action Committee. The value of the fish, \$218.75, was included on the 30-day Financial Disclosure Report.

Upon receipt of your letter and our subsequent conversation, an inquiry was made with OBI Seafoods, and it was determined that the donation did not come from a PAC, but from the company. I immediately issued check #2018 to OBI Seafoods for the full the amount of \$218.75. This expense was reported on the Seven Day Report.

This was a misunderstanding, and it was rectified as soon as my campaign was made aware of the issue.
