On September 10, 2025, the Commission reviewed Attorney General Taylor's request for an exemption from electronic filing. The Commission grants Attorney General Taylor's request to file tenant information using an alternative format.

I. Facts and Proceedings

For each year Tregarrick Taylor acted as Alaska's Attorney General, he is required to submit an annual statement disclosing his personal and financial interests for the preceding calendar year by no later than March 17, 2025. On March 18, 2025, Attorney General Taylor requested a public official filing exemption due to the APOC website's inability to upload a rental income file he and his spouse created to adhere to Alaska's Public Official Financial Disclosure laws. In the March 18, 2025 request, Attorney General Taylor noted it would be unduly burdensome to enter tenant information for 234 sources of rental income using the online portal.

During the hearing on September 10, 2025, APOC Staff noted it could accept an alternative filing format from Mr. Taylor and that an exemption from entering the data

online would still provide the public disclosure of Attorney General Taylor's incomeproducing tenants. APOC Staff further noted the Commission has the authority to grant a limited exception to electronic filing under 2 AAC 50.821.

II. Law and Analysis

Under Alaska's Public Official Financial Disclosure laws, the official's financial disclosure must be an accurate representation of the personal, business, and financial affairs of themselves and their family members,¹ "to the extent that it is ascertainable" by the filer after making a good faith effort to obtain the information.² A filer is not exempt from disclosure requirements "except to the extent state courts determine that legally privileged professional relationships preclude complete compliance." The methodology of disclosure is largely within the Commission's discretion.

Attorney General Taylor has asked the Commission whether he may file tenant information in an alternative format. Given that APOC concedes alternative filing does not impair the public's ability to ascertain his sources of income, the Commission unanimously grants the request to file by alternative means.

III. Conclusion

The Commission unanimously **GRANTS** Attorney General Taylor's request to file the tenant information by alternative means. To date, the filing technically has not

been made. And although there was some discussion at the September 10, 2025 hearing

whether Attorney General Taylor is required to produce the full names of all tenants, the

Commission does not believe that such a request has been sufficiently raised by either the

Attorney General or APOC Staff pursuant to 2 AAC 50.821. In the event Attorney

General Taylor seeks to withhold tenant information from public disclosure, he shall

formulate his position in writing for Commission review.

This is a final Commission order. It may be appealed to the superior court within

30 days from the date of this order. ⁴ A request for the Commission to reconsider this

order must be filed within 15 days from the date this order is delivered or mailed.⁵
