I. SUMMARY OF COMPLAINT

Jose Roel Antonio Tagle, Jr. filed a declaration of candidacy for Alaska House District 22 on June 1, 2026.¹ The same day, he submitted a Public Official Financial Disclosure (“POFD”) form listing no income, business interests, loans or debts, leases, close economic associations, or lobbyist partner employers.² Tagle listed two dependent children and a spouse on his POFD form.³

Public records maintained by the Alaska Division of Corporations reveal that Tagle holds at least one active and compliant business interest he failed to disclose. Specifically, Stardust Limited Liability Corporation., an Alaska business corporation formed on January 17, 2025, lists Jose Tagle as Director, President, and Shareholder with a 40% ownership stake.⁴ The entity remains in good standing as of the date of filing this Complaint.⁵ There

are two other shareholders: Hiram Tagle (30% as Secretary, Shareholder, and Treasurer) and Alarcón and Associates LLC (30% as Shareholder).⁶ Alarcón and Associates LLC appears to be another entity Tagle organized, which has been involuntarily dissolved.⁷ Tagle's interest in Stardust Limited Liability Corporation, is squarely within the scope of information AS 39.50.020 and AS 39.50.030 require candidates to disclose to be eligible for candidacy pursuant to AS 15.25.030(b).

On June 5, 2026, the Alaska Democratic Party ("ADP") filed a candidate eligibility complaint with the Division of Elections challenging Tagle's candidacy for House District 22.⁸ The complaint alleged that Tagle plainly failed to comply with Alaska's Public Official Financial Disclosure Act by filing a POFD form that listed no income, business interests, loans, debts, leases, close economic associations, or lobbyist partner employers, despite having demonstrable business interests of public record, including an ownership stake in Stardust Limited Liability Corporation.⁹

The complaint cited AS 39.50.020, which requires candidates for state office to "file a statement giving income sources and business interests, under oath and on penalty of perjury . . . at the time of filing a declaration of candidacy," and AS 39.50.060, which disqualifies noncompliant candidates.¹⁰ The complaint included documentary evidence from the Alaska Division of Corporations showing Tagle holds a 40% ownership interest

as Director, President, and Shareholder of Stardust Limited Liability Corporation.¹¹ On June 8, 2026, the Division's Election Program Manager sent an email to the Alaska Public Offices Commission (the "Commission") with a copy of Tagle's POFD attached, noting that it appeared "blank" online and inquiring whether there was "something wrong with it."¹²

On June 19, 2026, Division Director Carol Beecher issued a Decision denying the Complaint.¹³ The Decision concluded that the grounds cited in the complaint were "beyond the scope of DOE's review" under 6 AAC 25.260(c).¹⁴ The Division argued that the Commission has exclusive authority over statements required by AS 39.50 under AS 15.13.030(7), and therefore the Division would not consider the complaint's allegations.¹⁵ The Decision further noted that Tagle had timely filed a POFD and that "any review of which would be within APOC's authority."¹⁶ ADP appealed the Division's denial to the superior court.

Since filing its appeal, ADP has become aware of numerous additional reportable interests and other financial information which Tagle failed to include on his POFD form. For instance, Tagle and his wife, Beatriz Leon (aka Carolina Tagle), appear to own and operate two nightly rental operations in Anchorage, at least one of which was actively booking guests during the relevant reporting period.¹⁷ Moreover, publicly available records

indicate that Tagle had a child support judgment in excess of \$1,000 entered against him that may have remained unfulfilled during the reporting period.¹⁸ A writ of execution was also issued against Tagle in March of 2026 regarding an outstanding debt, among other examples.¹⁹ Although it is not strictly relevant for purposes of Tagle's compliance with AS 39.50, it bears noting that some of his business endeavors appear to be questionable.

Based on the significant evidence that Tagle is, in his own words, a "seasoned local businessman,"²⁰ it is clear that Tagle did not substantially comply with AS 39.50.020 and AS 39.50.030 by filing a POFD listing no reportable income, interests, or other financial information. Tagle should therefore be determined ineligible for candidacy. ADP respectfully requests that the Commission recommend that the Division remove Tagle from the general election ballot.

This matter is time sensitive, particularly in light of the Division's denial of ADP's complaint, and the upcoming deadline for candidates to be removed from the general election ballot. The Division has acknowledged that "an incorrect decision to include or not include a candidate on a ballot can cause irreparable harm to candidates and voters."²¹ If Tagle is on the ballot for the general election, despite being ineligible, one of two outcomes is inevitable. First, because there are only two certified candidates for the House District 22 seat, voters will be confronted with a binary choice and some voters will cast

ballots for an ineligible candidate, thus siphoning off votes from the only eligible candidate.²² Second, if Tagle ultimately secures enough votes to win the election, he will be required to forfeit nomination to office under AS 39.50.060(b), functionally discarding the ballots of those voters who cast votes for him. At that point, “there can be no do-over and no redress.”²³ The Division will not be able reissue ballots or hold another election without compromising the entire election process.²⁴

II. ALLEGATIONS

Tagle’s POFD does not substantially comply with AS 39.50.020 and AS 39.50.030 because it lists no reportable financial information whatsoever and therefore does not provide an “accurate representation of the financial affairs of the . . . candidate.”²⁵ At minimum, Tagle appears to have six potentially reportable sources of income, business interests, or debts which he did not disclose.

A. Stardust Limited Liability Corporation.

As described above, Division of Corporations records for Stardust Limited Liability Corporation., an entity in good standing, show Jose Tagle listed as Director, President, and Shareholder with a 40% ownership stake.²⁶ The two other shareholders, Hiram Tagle and Alarcón and Associates LLC, appear to be a family member of Tagle’s and another entity

of Tagle's that has been involuntarily dissolved, respectively.²⁷ ADP lacks information regarding the profitability of Stardust Limited Liability Corporation., its sources of revenue, or how much income Tagle generates from the company as a shareholder. However, Tagle's interest in Stardust Limited Liability Corporation. is subject to disclosure under AS 39.50.030(b)(2) as a business in which Tagle "has an interest or was a stockholder, owner, officer, director, partner, proprietor, or employee during the preceding calendar year."²⁸

B. Anchors Way Inn & Turnagain Inn

Information regarding Anchors Way Inn (aka Anchors Way Bed And Breakfast) and Turnagain Inn is difficult to ascertain from publicly available records. An entity formed in May of 2020 with the name "Anchors Way Bed And Breakfast LLC" lists Beatriz Leon as registered agent and member.²⁹ But Division of Corporations records note the entity has been involuntarily dissolved.³⁰ Nonetheless, Tagle claims on his Facebook page that he "and his wife own and operate [Anchors Way Inn], a welcoming bed-and-breakfast. Together they also opened the [Turnagain Inn] [*sic*], which is now proudly owned and operated by his family."³¹ Reviews on Google and TripAdvisor indicate that customers have booked lodging at both the Anchors Way Inn and the Turnagain Inn during the preceding calendar year.³² ADP also received information from a concerned traveler who

alleged that he reserved a room at the Turnagain Inn for two nights this month, July 2026, but was “defrauded” by Tagle and his wife, who declined to return his \$373.44 payment after he became aware that the Turnagain Inn “doesn’t exist anymore.”³³

ADP lacks information regarding the profitability of either Anchors Way Inn or Turnagain Inn or how much Tagle and Leon receive in income from the businesses, but both businesses are subject to disclosure under AS 39.50.030(b)(2) as businesses in which either Tagle or Leon “has an interest or was a stockholder, owner, officer, director, partner, proprietor, or employee during the preceding calendar year.”³⁴ Alternatively, the businesses may be subject to disclosure under AS 39.50.030(b)(1) as “sources of income over \$1,000 during the preceding calendar year.”³⁵

C. Child Support Lien

Publicly available records indicate that a lien for child support was recorded in August of 2023 listing Tagle as the obligor with an outstanding liability of \$2,296.16.³⁶ The statute authorizing this kind of lien, AS 25.27.230, specifically refers to the outstanding child support obligation as a “debt.”³⁷ Thus, the child support obligation may be subject to disclosure under AS 39.50.030(b)(5), which requires disclosure of “indebtedness . . . incurred . . . during the preceding calendar year, or if the amount still owing on the . . . indebtedness was more than \$1,000 at any time during the preceding

calendar year.”³⁸ ADP lacks information regarding the outstanding balance of Tagle’s child support obligation at this time.

D. Writ of Execution in Judgment Debtor Proceedings

Publicly available records indicate that a default judgment was entered against Tagle in the amount of \$2,659.56 in Case No. 3AN-21-00799SC.³⁹ In April of 2024, a writ of execution was issued, authorizing process servers to seize assets from Tagle’s bank accounts to fulfill the judgment.⁴⁰ A second writ of execution was issued in March of 2026.⁴¹ This debt may also be subject to disclosure under AS 39.50.030(b)(5). ADP lacks information regarding the outstanding balance of this debt at present.

E. Residence

On his declaration of candidacy, Tagle lists “8137 E 2nd Ave, Anchorage, AK 99504” as his residence. Publicly available records list Maria Leon, who appears to be Tagle’s mother-in-law, and Carlos Chavez as co-owners of the residential property at that address.⁴² 8137 E 2nd Ave is also the address listed for the Anchors Way Inn.⁴³ ADP lacks further information regarding the nature of Tagle or his wife’s interest in the 8137 E 2nd Ave property; however, whatever the interest is in the real property that allows him to claim it as his residence, it is either a “gift[] from a single source with a cumulative value exceeding \$250” subject to disclosure under AS 39.50.030(b)(1) or other “interest in real

property, including an option to buy,” under AS 39.50.030(b)(3), or some combination of both.⁴⁴

III. CONCLUSION

From publicly available records and cursory internet searches, Jose Tagle appears to own and operate several businesses, as he claims online himself. Notwithstanding the potentially suspect nature of these enterprises, Tagle therefore appears to have flagrantly violated AS 15.25.030(b), AS 39.50.020, and AS 39.50.030, which require candidates for state office to file POFD forms that constitute “an accurate representation of the financial affairs” of the candidate as a condition of eligibility for candidacy. Tagle’s POFD listed no information whatsoever, other than his name, his spouse’s name, and the fact that he has two dependent children. To the extent Tagle could have amended his POFD to correct these errors, that time has passed. The Commission should recommend that the Division remove Tagle from the ballot for the general election.

SUBJECT: Filing Deadline Procedures and Timely Candidacy Filings for the Primary Elections

EFFECTIVE DATE: June 24, 2025

PURPOSE: To establish filing deadline day procedures for the Primary Elections and for determining if candidacy filings were submitted timely.

AUTHORITY: AS 15.25.040

POLICY: June 1 of a general election year is the filing deadline for candidates to submit a Declaration of Candidacy form to appear on the Primary Election ballot.

All required candidacy forms and Legislative Financial Disclosure (**LFD**) or Public Office Financial Disclosure Statements (**POFD**) must be filed by 5:00 p.m. on June 1 to be considered timely.

Pursuant to a Supreme Court Decision rendered on April 18, 1986 and state statutes, the following procedures for accepting candidacy filings are to be strictly adhered to by the Division of Elections.

PROCEDURES

A. Filing Day Procedures for Acceptance of Filing Papers from Candidates

1. All candidate filings received by the division must be reviewed by a staff member following the appropriate X11 checklist. This checklist is an essential tool used to determine if there are deficiencies with the filing paperwork. The deficiencies must be corrected before the potential candidate leaves the office and by the 5:00 p.m. filing deadline. Declaration of Candidacy filings are reviewed following Policy and Procedure CF-3.
2. Date stamp all papers and record the "Time" in the appropriate field on the top of the checklist on the filing deadline.
3. Record how the filing was received; by fax, by email, by mail or in person.
4. Record the name of the division staff person and office location where the filing was received.

5. After the filing documents have been received and processed, and the checklist has been completed, email the following information to the Election Administrative Assistant and Election Program Manager:
 - a. checklist;
 - b. candidate's Declaration of Candidacy
 - c. the candidate's print-screen(s), marked "BEFORE" and "AFTER" if changes were made to the candidate's record;
 - d. photocopy of receipt for the filing fee, and
 - e. if received, a photocopy of the first page of the Legislative Financial Disclosure (LFD) or Public Official Financial Disclosure Statement (LFD or POFD) as proof of simultaneous filing with the Alaska Public Offices Commission (APOC).
6. The receiving office scans and drops the scans in the Public drive here: V:\NU-Public\Candidacy Filings\Sent, then emails the Election Admin Asst. & Election Program Manager advising they have dropped the filing in the folder.

B. Director's Office Filing Day Procedures

1. Candidacy filings received on the Filing Deadline Day will be posted immediately to the division's website following entry into the *Candidate Log*. This allows the public to better track who has filed while the paperwork is being processed.
2. Upon receipt of the emailed, faxed, scanned, or original filing paperwork, the Election Administrative Clerk enters the candidacy filing information into the *Candidate Log*. The paperwork is then forwarded to the Election Administrative Assistant to enter the information in the candidate spreadsheet and VREMS for posting on the website.
3. The candidate information entered in VREMS is periodically transferred to the candidate information section on the website at a predetermined time between the Election Administrative Assistant and Webmaster. The website should display the candidate's name, address, party/group affiliation or nonpartisan/undeclared designation, if requested, email, web address and phone number, if applicable, under the corresponding office/race heading on the appropriate candidate page.
4. Once the Director has signed the candidate letter, the Election Administrative Assistant will change the candidate's details in VREMS from a "Pending" status to "Certified". The Webmaster will update the website with the new status information and if certified, nothing will be listed next to the candidate's name. If the candidate has been denied, the word "Denied" with a short description explaining the reason for denial will be posted next to the appropriate candidate's name.

C. Timely Filing Received In Person • Declaration of Candidacy

1. All filing papers for a Declaration of Candidacy that are filed in person with the Division of Elections are considered to be filed timely if:
 - a. all information requested is provided on the forms;
 - b. the required fee accompanies the Declaration of Candidacy form;
 - c. proof of filing a current LFD or POFD report with APOC accompanies the Declaration of Candidacy form (or the LFD or POFD report is able to be verified directly with APOC);
 - d. the forms are properly signed and witnessed by the 5:00 p.m. June 1 filing deadline of even numbered years; and
 - e. the completed documents are date stamped or noted by a division staff member that they were received by the 5:00 p.m. June 1 filing deadline.
2. To assure that last minute filings are handled as expeditiously as possible, at 4:00 p.m. on the June 1 filing deadline, at least one individual is assigned to receive only those documents that are complete and do not need to be notarized.
3. At 4:00 p.m., the Regional Election Supervisors and the Election Program Manager announce the time and points out the "legal" clock that is used to determine the 5:00 p.m. June 1 filing deadline. If any conflicts, arguments or problems occur at that time, the individual is directed to the Director and there are no further discussions with the regional or director's office staff.
4. All regional and director's office staff will be trained and available to handle last minute filing documents.
5. Any documents needing witness by a division notary must be signed and dated by the 5:00 p.m. June 1 filing deadline. However, the documents may be imprinted with the seal after 5:00 p.m.

D. Timely Filing Received By "Reliable Electronic Transmission" - Declaration of Candidacy

1. Filing by "Reliable Electronic Transmission" is defined as filing by fax or email.
2. A Declaration of Candidacy may be faxed or emailed to the Division of Elections. It is considered timely under the following conditions:
 - a. received by 5:00 p.m. on the June 1 filing deadline a fax or email is received by the Division of Elections.

- b. the fax or email must include a fully completed Declaration of Candidacy form or the following information:
 - (i) the candidate's full name;
 - (ii) the candidate's mailing address;
 - (iii) if running for state senate or house, the district in which the candidate resides;
 - (iv) the office the candidates seeks nomination;
 - (v) the candidate's political party/group affiliation, nonpartisan/undeclared designation, if requested and
 - (vi) proof of simultaneous filing a current LFD or POFD with APOC.
 - c. the original Declaration of Candidacy, proof of a current LFD or POFD report with APOC and filing fee are mailed and postmarked by the June 1 filing deadline and received within 15 days by the Division of Elections.
3. The clock for the faxes in all election offices is set the same as the official clock. A colored piece of paper is inserted in the fax machine's "receive bin" at 5:00 p.m. on the June 1 filing deadline. Any faxes received after that are marked "Received After 5:00 p.m." and are considered invalid.

E. Timely Filing Received By Mail• Declaration of Candidacy

- 1. All filing papers for a Declaration of Candidacy that are filed by mail are considered timely if:
 - a. all information requested is provided on the forms;
 - b. the candidate meets the required qualifications;
 - c. the required fee accompanies the Declaration of Candidacy form;
 - d. proof of filing a current LFD or POFD with APOC is provided (or the LFD or POFD report is able to be verified directly with APOC);
 - e. the forms are properly signed and witnessed by the 5:00 p.m. June 1 filing deadline of even numbered years; and
 - f. the completed documents are date stamped or noted by division staff that they were received by the 5:00 p.m. June 1 filing deadline.
 - g. If the postmark is illegible, a dated receipt from the post office where dispatched will be acceptable evidence of mailing.

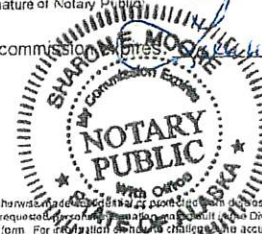

To whom it may concern:

This complaint is hereby submitted on behalf of the Alaska Democratic Party to formally request that House District 22 candidate Jose Roel Antonio Tagle be removed from the ballot for knowingly failing to comply with Alaska's Public Official Financial Disclosure Act. Pursuant to AS 39.50.060, Mr. Tagle is ineligible for nomination and installment in office and should not have been certified as a candidate.

Mr. Tagle filed a POFD form listing no income, business interests, loans or debts, leases, close economic associations, or lobbyist partner employers. AS 39.50.020 requires candidates for state office to "file a statement giving income sources and business interests, under oath and on penalty of perjury . . . at the time of filing a declaration of candidacy or a nominating petition or becoming a candidate by any other means." AS 39.50.060 not only makes knowing failure to comply with AS 39.50.020 a misdemeanor offense; the statute also disqualifies a noncompliant candidate from being nominated or installed in office. Upon information and belief, Mr. Tagle, who listed two dependent children and a spouse on his POFD form, has business interests and income that he did not report, including an interest in Stardust Limited Liability Corporation.

The Division of Elections (DOE) received the Alaska Democratic Party's complaint regarding the eligibility of Jose Roel Antonio Tagle as a candidate for House District 22. DOE has determined that the grounds cited in the complaint are beyond the scope of DOE's review. 6 AAC 25.260(c).

The complaint alleges that Mr. Tagle failed to report business interests and income on his Public Official Financial Disclosure (POFD) form. Candidates for state office must have disclosure forms on file when they file their declarations of candidacy. *See* AS 15.25.050(b); AS 39.50.020. The complaint seeks to disqualify Mr. Tagle under AS 39.50.060, which provides that those who do not comply with AS 39.50 "shall forfeit nomination to office and may not be seated or installed in office."

DOE cannot consider grounds related to issues over which the Alaska Public Offices Commission (APOC) has authority under AS 15.13. 6 AAC 25.260(c). Under AS 15.13.030(7), APOC has authority over statements required by AS 39.50. Accordingly, DOE cannot consider the grounds cited in the complaint. Mr. Tagle timely filed his POFD, any review of which would be within APOC's authority. Mr. Tagle has also not yet been nominated or elected to office. *See* AS 39.50.060(b).

Additionally, the complaint does not appear to include the "name, mailing address, contact phone number, and signature of the person making the complaint," as required by 6 AAC 25.260(b). The complaint is filed "on behalf of the Alaska Democratic Party" and includes its address and phone number yet it also lists your name and is signed by counsel. Nevertheless, DOE responds to this complaint because DOE did not note these deficiencies when the complaint was delivered on June 5, 2026.

This determination is a final decision and DOE will provide a copy of it and the complaint to Mr. Tagle. You have 30 days from the date of this decision to appeal to the superior court. 6 AAC 25.260(i); AK R. App. P. 601, 602.

Dianne Morrison, being first duly sworn, deposes and states as follows:

1. I have personal knowledge of the facts contained herein and am competent to testify thereto.

2. On July 28, 2026 I requested North Country Process Service ("NCPI") serve Jose Roel Antonio Tagle, Jr. ("Tagle") with a copy of the Complaint filed on July 28, 2026 with the Alaska Public Offices Commission ("Complaint") at 4 different addresses:
