#### DECISION

## I. Introduction

This case is Ms. U E's appeal of the decision by the Division of Public Assistance (or Division) to deny her application for General Relief Assistance (GRA) benefits for cremation expenses for her father-in-law, B S. The Division denied these benefits because Mr. S' monthly income exceeded \$300 in March of 2013, which was the month he died and the month that the application for these benefits was filed.

Ms. E admitted Mr. S' monthly income exceeded \$300, but argued that it would be unfair to apply the monthly income limit in his case.

The Division's denial of GRA benefits for cremation expenses for the late B S must be upheld. There is no exception to the \$300 monthly income limit applicable to Ms. E's application.

## II. Facts

Mr. S died on March 4, 2013. <sup>1</sup> Ms. E applied the following day for GRA benefits to cover his cremation. <sup>2</sup> On her application, Ms. E listed \$1,509.40 in Social Security benefits as monthly non-work income for Mr. S at the time of his death.<sup>3</sup> On March 6, 2013, the Division mailed a notice to Ms. E stating that her application was denied because Mr. S' income exceeded the \$300 monthly limit. <sup>4</sup> Ms. E appealed that decision.

Ms. E's appeal was heard by telephone on March 27, 2013. The hearing was audio recorded. Ms. E represented Mr. S' estate, and testified on its behalf. DPA Public Assistance Analyst Jeff Miller represented the Division.<sup>5</sup>

Ms. E admitted at the hearing that Mr. S received \$1,509.40 in Social Security benefits, but she argued that it was unfair to include that benefit as income, because almost all of that money went to the assisted-living home he lived in when he died.<sup>6</sup>

#### III. Discussion

Ms. E is understandably frustrated that Social Security benefits that were not available to help with cremation expenses were applied to the monthly income limit that made the late Mr. S ineligible for General Relief Assistance for his cremation. The regulations that set the eligibility requirements for this assistance are very strict, however. Alaska Regulation 7 AAC 47.150 sets the monthly income limit for a household of one at \$300. This regulation provides a limited list of deductions from the income before the monthly is compared to the \$300 limit. That list does not include money collected by the assisted living facility where the decedent was living.<sup>7</sup>

#### IV. Conclusion

Mr. S did not qualify for General Relief Assistance for his cremation. The Division's decision is AFFIRMED.
