ORDER GRANTING MOTION TO DISMISS

On May 27, 2005, the Alaska Department of Revenue Permanent Fund Dividend Division (Division) filed a Motion to Dismiss, asserting that C.D.M.'s request for an informal appeal was not timely filed and asking that the filing deadline in this case be enforced. Mr. M. did not respond to the motion. The Administrative Law Judge grants the Division's motion.

This case is Mr. M.'s late appeal of the Division's denial of his 2004 Permanent Fund Dividend (PFD) application. The Division denied this application because the Division determined that Mr. M. did not show that he had re-established residency in Alaska before January 1, 2003.

The Division argues that Mr. M.'s appeal should be dismissed because he failed to file his request for an informal appeal within 60 days of the date of issuance of the Notice of Denial of his 2004 PFD application, as required by 15 A A C 05.010.

The Notice of Denial explaining the denial of Mr. M.'s 2004 PFD application was issued, January 7, 2005.¹ The deadline for filing the request for an informal appeal for Mr. M.'s 2004 PFD application was March 8, 2005.² Mr. M.'s request for an informal appeal was postmarked April 7, 2005.³

Mr. M. is not entitled to a review of the merits of the Division's denial of his 2004

PFD application.⁴ It would not work an injustice to strictly apply the appeal deadline in this case.⁵ Mr. M. has not provided an explanation that would excuse his failure to file his appeal until a month after the deadline.⁶

Therefore, the Division's Motion to Dismiss is GRANTED. This case will not be scheduled for a formal hearing. The Division's denial of C.D.M.'s application for a 2004 PFD is affirmed.
