DECISION

I. Introduction

E D's application for a 2015 permanent fund dividend (PFD) was denied because he was incarcerated during the qualifying year, 2014, as a result of a felony conviction. Following an unsuccessful informal appeal, Mr. D requested a formal hearing.

Mr. D's hearing was held on October 26, 2015. Mr. D represented himself. PFD Specialist Peter Scott represented the PFD Division.

Because Mr. D was incarcerated in the qualifying year, 2014, as a result of a disqualifying condition, he was not eligible to receive the 2015 PFD.

II. Facts

Mr. D timely applied for a 2015 PFD. The Division has raised no issue regarding Mr. D's eligibility apart from his incarceration during the qualifying year, 2014.

Mr. D was convicted of two felony charges on April 29, 2005, case number 3HO-04-00000CR.¹ He subsequently had a bench warrant issued for a probation violation. He was arrested based upon that bench warrant on May 19, 2014.² He was then incarcerated from May 19 through June 30, 2014. On June 30, 2014, he was released from jail and his probation was reinstated.³ On December 14, 2014, he was released from probation.⁴

III. Discussion

The Alaska legislature has directed that "an individual is not eligible for a permanent fund dividend for a dividend year when . . . (2) during all or part of the qualifying year, the individual was incarcerated as a result of the conviction in this state of a (A) felony." This includes incarceration for a probation violation when the original sentence was for a felony.⁵

The qualifying year for a 2015 dividend was 2014.⁶ Mr. D was undeniably incarcerated in 2014, which arose out of a 2005 felony conviction in court case number 3HO-04-00000CR. His 2014 incarceration disqualified him from receiving a 2015 dividend.

As the individual challenging the Division's decision, it is Mr. D's burden to establish that it is more likely than not that he is eligible for a 2015 PFD.⁷ Mr. D failed to meet his burden.

IV. Conclusion

Mr. D is not eligible to receive a 2015 PFD. The decision of the division is affirmed. DATED this 3rd day of November, 2015.
