CORRECTED¹ ORDER OF DISMISSAL

On January 25, 2006, the Department of Commerce, Community, and Economic Development, Division of Banking and Securities, (Division) filed a motion requesting an order dismissing with prejudice the request for a hearing filed by respondent George Heffeman, on behalf of himself and his business, Index Analysis Pool, LP, due to Mr. Heffernan's failure to participate in this proceeding.

Good cause has been shown for granting the relief requested. Mr. Heffeman filed this appeal, but Mr. Heffeman has failed to prosecute his appeal diligently.² At a status conference on October 17, 2005, Mr. Heffeman agreed to negotiate with opposing counsel, but he has not responded to any communications since November 2, 2005.³ Mr. Heffeman failed to appear at the scheduled status conferences on November 21, 2005 and January 6, 2006. I called his phone number of record at the time of both these status conferences and left messages instructing Mr.

The Order of Dismissal in this case was issued and distributed to the parties. The Division then filed a Request for Typographical Correction, pointing out that there was a typographical error in the order. Therefore, this corrected order is issued at the Division's request, in place of the original. It is identical to the original, with the exception of the correction, which appears in bold italic type. The parties' responses to the proposed order still must be filed by the date on the notice that was attached to the original proposed order.

Heffernan to file a request to reschedule if he wished to pursue his appeal. He did *not* file such a request.

The Division's Motion to dismiss is GRANTED. This case will not be scheduled for formal hearing. Mr. Heffernan's request for a hearing is dismissed.
