ADEC issues this preliminary decision under the authority of AS 46.14 and 18 AAC 50. The Division of Governmental Coordination (DGC) found the Northstar Development Project consistent with the Alaska Coastal Management Program (ACMP) on February 5, 1999, and subsequent project changes consistent on December 15, 1999. BP has requested changes to stipulations imposed to protect air resources on the North Slope Borough.

ACMP: The ADEC is reviewing changes to project activities for consistency under the Alaska Coastal Management Program (ACMP), 6 AAC 50 and AS 44.19. Comments regarding inconsistency with an affected coastal district's enforceable policy or a State standard set out in 6 AAC 80.040-6AAC 80.150 must identify the enforceable policy or standard and explain how the project is inconsistent. Your comments must be received by ADEC by 4:30 p.m. March 6, 2000, to preserve your rights to file a petition under AS 46.40.100(b)(1).

Applicant: BP Exploration (Alaska), Inc., P.O. Box 196612, Anchorage AK 99519-6612

Location: The Northstar Project production area is located on Seal Island, six miles north of Point McIntyre/Point Storkerson in the Beaufort Sea off the North Slope of Alaska. The site is approximately 14 miles northwest of Prudhoe Bay. UTM Zone 6, NAD 27, 436897.87 East, 7821340.08 North.

Activity: BP has proposed minor project scope changes to the Northstar Project emission sources originally permitted under Permit No. 9873-AC020. The Northstar Project consists of the expansion of Seal Island for development and the installation of an oil production facility. BP proposes to add thirteen 25,290 gallon temporary fuel storage tanks to the site. BP also proposes changes to existing permit conditions for emission limits, monitoring, and reporting.

Emissions: The potential to emit regulated air contaminants from the Northstar Project is: 664 tons per year of oxides of nitrogen (NOx), 47 tons per year sulfur dioxide (SO<sub>2</sub>), 421 tons per year carbon monoxide (CO), 108 tons per year particulate matter emissions (PM<sub>10</sub>), and 92 tons per year volatile organic compounds (VOC). The proposed project scope change adding 13 temporary fuel storage tanks will increase VOC emissions by 0.2 tpy.

Department Preliminary Review: Based on review of the BP Northstar Project Construction Permit Application, ADEC has prepared a preliminary permit decision to issue Construction Permit No. 0073-AC001.

Based on PSD review by ADEC, the project as revised:

1. Will not cause or contribute to a violation of any State Ambient Air Quality Standard or increment set out in 18 AAC 50.010 and 18 AAC 50.020(b);
2. Will be controlled by Best Available Control Technology (BACT); and
3. Will not adversely affect the air quality-related values of noise, odor, visibility, vegetation, and soils of the state.

This proposed decision revises terms and condition of a permit issued in January 1999.

NOTICE OF PROPOSED CHANGES IN THE  
REGULATIONS OF THE DEPARTMENT OF NATURAL RESOURCES

Notice is given that the Department of Natural Resources, under the authority of AS 38.05.020, proposes to adopt, amend, and repeal regulations in Title 11 of the Alaska Administrative Code, dealing with public easements, to implement AS 19.10.010, AS 19.30.400-420, AS 38.04.058, AS 38.04.200, AS 38.05.127, and AS 40.15.305, including:

In 11 AAC 05.010, a fee for nominating RS 2477 rights-of-way for certification would be deleted.

An existing chapter of regulations, 11 AAC 51, dealing with RS 2477 rights-of-way, would be expanded to cover all public easements managed by the department, including RS 2477 rights-of-way. Other types of easements are currently covered in 11 AAC 53, but those regulations would be amended and renumbered into 11 AAC 51.

Within 11 AAC 51, the existing sec. 010 would be expanded to describe the content and purpose of the proposed public easement regulations. New secs. 015, 025, 035, and 045 would set out width and reservation standards for general-purpose access and utility easements, section-line easements, and easements to and along navigable and public rivers and lakes. A new sec. 055 would set out how the department will research, identify, and request information from the public on historic trails that appear to qualify under RS 2477 before reporting those trails to the legislature under AS 19.30.400, and who will manage such rights-of-way. A new sec. 065 would say how a person may request the department to vacate (erase) or relocate a public right-of-way, and define standards the department will apply to the decision. A new sec. 075 would cover markings or signs on public easements. A new sec. 085 would renumber 11 AAC 53.305, dealing with access to mental health trust land, but without amending it. New sec. 200 would set out how the department will manage public easements, including restricting access in some circumstances, and would require the department to seek public comment before authorizing work that changes the way an easement has traditionally been used. A new sec. 210 sets out rules applicable to the public's use of an easement. New secs. 910-990 provide for appeals of decisions regarding public rights-of-way deal with liability for injury, accident, or damage that happens on a public easement and define terms used in the chapter.

The existing 11 AAC 51.020 - 100, dealing with RS 2477 right-of-way nomination, evaluation, certification, appeals, classification, and management, are proposed to be repealed. Many of these topics would be incorporated into new regulations as proposed above. However, the process of identifying RS 2477 rights-of-way would no longer have any formal nomination or certification steps (see proposed 11 AAC 51.055).

In 11 AAC 53, the entire article dealing with easements (11 AAC 53.300 - 370) would be repealed. As noted above, these rules would be incorporated into the new regulations proposed for 11 AAC 51.

Notice is also given that any interested person may present written comments on the proposed action, including the potential costs to private persons of complying with the proposed action. On November 10, 1999, the Alaska Coastal Policy Council (CPC) approved the revised regulations at 6 AAC 50 clarifying the meaning of and providing threshold criteria for demonstrating status as a citizen of an affected coastal district with regard to a petition to the CPC. The regulations were then reviewed,

amended, and approved by the Department of Law. Following the Department of Law review and approval, the regulations were submitted to the federal Office of Ocean and Resource Management (OCRM) for incorporation into the Alaska Coastal Management Program as a routine program change. An initiative petition, "Bill Legalizing Hemp (Marijuana)" (99HEMP) was certified on February 2, 2000 by Lieutenant Governor Ulmer for the 2000 general election. The initiative petition summary states that this bill would shield those 18 years or older from civil and criminal sanctions for the use of marijuana and other hemp products. Doctors would be allowed to prescribe marijuana, and it would be regulated like an alcoholic beverage. Amnesty would be given to those convicted in the past of marijuana crimes. The bill allows for laws limiting marijuana use in some cases to protect public safety. It directs the state to challenge federal laws that conflict with the terms of the bill. It creates an advisory panel to study restitution for persons convicted in the past of marijuana crimes.

AS 14.45.140 requires that the petition must be signed by qualified voters equal in number to 10 percent of those who voted in the preceding general election and resident in at least two-thirds of the election districts of the state. In 1998, there were 227,156 qualified voters, therefore, the signatures of 22,716



qualified voters in at least 27 election districts were required. The Division of Elections verified 24,474 signatures of qualified voters.

Alaska Statute 15.45.240 states that within 30 days of the date on which notice of the determination was given, any person aggrieved by a determination made by the Lieutenant Governor may bring action in the superior court to have the determination reviewed.

The ballot title and proposition will be prepared with the assistance of the Attorney General and placed on the November general election ballot. However, if the Legislature enacts laws this session that are substantially the same as the proposed ballot initiative, the initiative would be declared void and the ballot proposition will not appear on the November ballot.
