As required by AS 44.62.250, notice is given that, under the authority of AS 47.05.010, on April 26, 2000, the Department of Health and Social Services adopted, as an emergency regulation, changes to Title 7 Chapter 43 relating to additional payments to public hospitals, to implement AS 47.07.030, AS 47.07.040, AS 47.07.070, and AS 47.07.073.

An informative summary of the regulation changes is as follows: These regulations allow an additional payment to be made to qualified public hospitals to assure continued access to inpatient hospital services by Medicaid eligible persons. Under 7 AAC 43.677 the regulations authorize additional payments to qualified public hospitals in order to ensure continued access to inpatient services, establish criteria under which a public hospital may qualify for participation in the additional payments, describe intergovernmental transfer requirements for additional payments, describe the method for identification of available funds and methodology for determining distribution of payments among qualified public hospitals including the source for information about hospital occupancy levels, the provisions for resolution of disputes or appeals regarding additional payments. An addition to 7 AAC 43.686 identifies an intergovernmental transfer made pursuant to an agreement established under 7 AAC 43.677 as a cost that is not an allowable cost for purposes of calculating a prospective payment rate.

The finding of emergency is based on the urgency of cash flow needs in public hospitals due to low occupancy levels. Many public hospitals have a low occupancy level, and related lower cash flow. Some

of these public hospitals are struggling to keep their doors open to serve the medical needs in their communities and service areas. The division seeks to ensure continued access to inpatient hospital care through additional payments related to upon occupancy level to qualified, participating public hospitals.

This regulation took effect on April 26, 2000. The emergency regulation will expire August 23, 2000 unless it is made permanent by the Department of Health and Social Services.

This action is not expected to require an increased appropriation.

The proposed permit will also authorize discharges from off-shore vessels (operating more than one nautical mile from shore at MLLW) that are engaged in the processing of seafood paste, mince or meal, as well as fresh, frozen, canned, smoked, salted and pickled seafoods. The proposed permit will authorize discharges of processing wastes, process disinfectants, sanitary wastewater and other wastewaters, including domestic wastewater, cooling water, boiler water, freshwater pressure relief water, refrigeration condensate, water used to transfer seafood to a facility, and live tank water. The proposed permit will authorize discharges to waters of the United States in and contiguous to the State of Alaska, except for receiving waters excluded from coverage as protected, special, at-risk, degraded waters, or as waters adjacent to the City of Kodiak or the Pribilof Islands (and covered by general permits specific to each of these areas).

The proposed general NPDES permit for seafood processors in Alaska will not authorize discharges from near-shore or shore-based seafood processors of mince, paste or meal (operating one nautical mile or less from shore at MLLW). The proposed permit will not authorize discharges of petroleum hydrocarbons, toxic pollutants, or other pollutants not specified in the permit.

This is the fourth reissuance of a general permit for seafood processors in Alaska. The proposed draft permit has few changes from the general permit issued in August 1995. The proposed permit clarifies requirements of the Notice of Intent to be covered, gives specific schedules for submitting seafloor monitoring surveys, and maintains the State of Alaska Department of Environmental Conservation's mixing zones and zone of deposit as provided in the state certification of the 1995 permit. The proposed permit limits the total annual load of settleable solid seafood processing waste residues to ten million pounds of offal per year based upon the results of modeling the deposition of offal on the seafloor using EPA's Water Quality Analysis Simulation Program (WASP).

A draft NPDES permit, fact sheet and other documents of the administrative records are available upon request.

Public comments: Persons wishing to comment on the tentative requirements and conditions contained in the proposed general permit may do so before the expiration date of the public notice. EPA appreciates both supportive and critical comments in this public review and comment period. All persons, including applicants, who believe any condition of a draft permit is inappropriate or that the Director's tentative decision to prepare this draft permit is inappropriate, must raise all reasonably ascertainable issues and submit all reasonably available arguments supporting their position by the close of the public comment period. Any supporting materials which are submitted shall be included in full and may not be incorporated by reference, unless they are already part of the administrative record or are a generally available document or reference. All written comments must include the name, address, and telephone number of the commenter and must be submitted to EPA to the attention of Burney Hill at the address below on or before the expiration date of the public notice.

After the expiration date of the public notice, the Director, Office of Water, EPA Region 10, will make a final determination with respect to reissuance of the general permit. The tentative requirements contained in the draft general permit will become final conditions if no substantive comments are received during the public comment period. The permit will become effective on August 5, 2000.

Within 120 days following the service of notice of EPA's final permit decision under 40 CFR 124.15, any person who filed comments on the draft permit or participated in the public hearing may appeal the permit in the Federal Court of Appeals in accordance with section 509(b)(1) of the CWA. Persons affected by a general permit may not challenge the conditions of the Permit as a right of further EPA proceedings.

In addition to the tentative requirements of the draft general permit, the State of Alaska will issue a Determination of Consistency with the Alaska Coastal Management Program and State Certification which may contain specific requirements which will be incorporated into the final permit. Crude oil is delivered by tankers and pumped into storage tanks. It is piped to the crude unit where the following petroleum products are separated: fuel gas, liquified petroleum gas (LPG), fuel oil, naphtha, light gas run, diesel, and gas oil. LPG, naphtha, gas oil, and light gas run are then fed through the LPG unit, reformer unit, hydrocracker unit, vacuum unit, and isomerization unit to produce more refined products such as propane, butane, fuel gas, reformat, jet-A fuel, and isomerase. The facility also produces asphalt in the summer months.

Wastewaters from the refining process are treated in a multi-step process to reduce pollutant levels prior to discharge to Cook Inlet.

Tesoro also operates a remediation system for on-site, contaminated groundwater. Groundwater contaminated with petroleum products is pumped to a treatment system to remove volatile hydrocarbons. Tesoro has applied to discharge the majority of treated wastewater along with refinery wastewaters to Cook Inlet. The remainder is to be discharged to a trench system (for infiltration back to groundwater). The remediation system is authorized by a RCRA Part B permit and a state infiltration permit. The remediation wastewater discharge to Cook Inlet is authorized in this NPDES permit.

The Alaska Department of Transportation and Public Facilities (ADOT&PF) is proposing to overlay Egan Drive and improve access at the Salmon Creek and mile 2.5 Glacier Highway intersections.

Egan Drive would be overlaid with asphalt pavement between 10th Street and Mendenhall Loop Road. The overlay would increase the useful service life of the road and provide a safe driving surface. Work would also include paving under the guardrails, structural pavement repairs, and miscellaneous drainage and pavement improvements.

Vehicles entering Egan Drive at the Salmon Creek intersection and at the access road adjacent to the Juneau Empire presently merge with traffic at substantially different speeds. Consequently, traffic flow is disrupted and the potential for accidents is high. ADOT&PF will propose to construct an acceleration lane for eastbound traffic at the Salmon Creek intersection and close the Egan Drive access adjacent to the Juneau Empire Building and DIPAC Hatchery. The acceleration lane at the Salmon Creek intersection would minimize traffic disruption of traffic flow and lessen accident potential.

At the mile 2.5 Glacier Highway intersection with Egan Drive, traffic flow is presently disrupted by vehicles entering Egan Drive and by vehicles slowing down to exit Egan Drive. ADOT&PF will propose to construct a northbound acceleration lane and deceleration lane, and extend the deceleration lane for southbound traffic turning onto Glacier Highway. The northbound acceleration lane would require filling up to 0.13 acres of estuarine intertidal wetlands and palustrine wetlands. The northbound deceleration lane would require filling up to 0.17 acres of estuarine intertidal wetlands. Measures to minimize the wetland fills will be investigated during project design. The acceleration and deceleration lanes would minimize the disruption of traffic flow and lower the potential for traffic accidents at this intersection.
