

### **Notice of Utility Tariff Filing**

The REGULATORY COMMISSION OF ALASKA ("Commission") gives notice that the Alaska Exchange Carriers Association, Inc. ("AECA") filed a tariff revision designated as TA152-999. The filing proposes to implement an increase in the Network Access Fee ("NAF") in compliance with regulations adopted in Dockets R-08-003/R-09-003. The NAF affects all end-users that subscribe to local exchange telephone service. The proposed effective date of this filing is August 1, 2015.

The NAF will increase from \$5.25 to \$5.75 per month for the following local exchange carriers: Adak Eagle Enterprises, LLC d/b/a Adak Telephone Utility; Alaska Telephone Company; Bettles Telephone, Inc.; Bristol Bay Telephone Cooperative, Inc.; Bush-Tell, Incorporated; Circle Telephone; North Country Telephone Company; Nushagak Electric & Telephone Cooperative, Inc.; OTZ Telephone Cooperative, Inc.; Summit Telephone & Telegraph Company of Alaska d/b/a Summit Telephone Company; United-KUC, Inc.; United Utilities, Inc.; and Yukon Telephone Company, Inc.

The Commission may approve a rate or classification which varies from those proposed. You may obtain more information about this filing by contacting Judith A.
