SUBJECT: Corrections to the Alaska  
Administrative Code (AAC):  
12 AAC 70.220(e); 12 AAC  
70.935(g), (h)

In accordance with the authority of the regulations attorney under AS 44.62.125(b), please forward to the publisher the corrections to the Alaska Administrative Code (AAC) described below. I have forwarded these corrections under a specific delegation dated May 2, 2014 from the regulations attorney. These revisions correct manifest errors.

The regulations to be revised are 12 AAC 70.220(e) and 12 AAC 70.935(g) and (h), filed on May 29, 2015 with an effective date of June 28, 2015. The revisions to those subsections are as follows:

--In 12 AAC 70.220(e), change "Appraisal Qualifications Board Course Approval Program of the Appraisal Foundation" to "Appraiser Qualifications Board Course Approval Program of the Appraisal Foundation", i.e., change the very first word of the phrase from "Appraisal" to "Appraiser" (but keep "Appraisal Foundation" as is).

At the end of the editor's note that follows 12 AAC 70.220, add a new paragraph to read:

As of Register 215 (October 2015), the regulations attorney made a technical correction under AS 44.62.125(b)(6), to 12 AAC 70.220(e).

--In 12 AAC 70.935(g) and (h), change "Appraisal Qualifications Board of the Appraisal Foundation" to "Appraiser Qualifications Board of the Appraisal Foundation", i.e., change the very first word of the phrase from "Appraisal" to "Appraiser" (but keep "Appraisal Foundation" as is).

After 12 AAC 70.935, insert an editor's note to read as follows:

**Editor's note:** As of Register 215 (October 2015), the regulations attorney made technical corrections under AS 44.62.125(b)(6), to 12 AAC 70.935(g) and (h).
