## **Notice of Utility Tariff Filing**

The REGULATORY COMMISSION OF ALASKA (Commission) gives notice that Chugach Electric Association, Inc. (Chugach) filed tariff revision TA408-8, requesting Commission approval of Amendment No. 3 to its 2013 Gas Sale and Purchase Agreement with Hilcorp Alaska, LLC.

The key provisions of the proposed amendment include:

- Extends the term of the agreement from March 31, 2019 to March 31, 2023.
- Reduces the contract price of natural gas from \$8.03 to \$7.35 per Mcf starting in Contract Year 5 (April 1, 2018 to March 31, 2019), followed by 2 percent annual increases in Contract Years 6 through 9.
- Increases the Annual Contract Quantity in Contract Year 5 from 3.3 Bcf to 6.9 Bcf, and provides 5.5 Bcf in Contract Years 6 through 9.
- In Contract Years 5 through 9, allows Chugach to purchase additional minor volumes during the contract years as needed.

This notice may not contain all requested revisions and the Commission may approve a rate or classification, which varies from that proposed.
