
This action is not expected to require an increased appropriation.

**Chapter 02. General Occupational Licensing Functions.**

12 AAC 02.325 is amended to read:

**12 AAC 02.325. Board of Professional Counselors.** The following fees are established for professional counselors:

- (1) application fee for any initial license, \$200 [\$125];
- (2) license fee for all or part of any initial biennial license period, \$650 [\$400];
- (3) any biennial license renewal fee, \$650 [\$400];
- (4) any board-approved supervisor fee, \$200 [\$125]; (Eff. 5/5/99,
