#### **ANSWERS TO CONTRACTOR QUESTIONS FROM THE November 20<sup>th</sup>**

##### **PRE-BID WALK THROUGH (sign in sheet attached):**

1. **Question** - There two (2) types of bathroom floor plans. **How many of each are there?**

**Answer** - There are 3 Type A bathrooms and 7 Type B bathrooms – See Sheet M1.0

2. **Question** - The ceilings in the bathrooms directly beneath the project bathrooms will need to be accessed for construction. There is a mixture of hard lidded gypsum and concrete ceilings. **Which bathrooms are hard lidded and which are concrete?**

**Answer** - There are:

- 7 hard lid gypsum ceilings: Bathroom Suite #'s 301/302, 303/304, 305/306, 307/308, 313/314, 315/316 and 339/340
- 3 concrete ceilings: Bathroom Suite #'s 309/310, 311/312 and 334/335
