The Contract Documents for the above project are amended as follows (All other terms and conditions remain unchanged):

GENERAL - QUESTIONS AND ANSWERS

- 1. Q: Page 1 of the Invitation for Quotes says "Any project in excess of \$100,000 must be bonded. The attached Form 25D-10A says "N/A" for the amount of both the Payment Bond and the Performance Bond. Lastly, The Special Notice page says No bond is required.
 - Question: Is a bond required for this project?
 - A: See Item 5 below.
- 2. Q: On page 1, paragraph B.(1) of the Contract Technical Specifications the contract term is shown as "DATE OF AWARD through June 30, 2016". On page 18, paragraph (XI) F is a requirement to include a bid for 12 months, even though the previously stated contract term is 3 months.

Ouestion: What is the contract term?

- A: Please see Contract Technical Specifications paragraphs (I) B. (1)(2) and (XI) F, Form SPC-001 Description of Work, Required Completion Date, Listing of Attachment: Section and Form SPC-002 Quote: Section.
- 3. O: Please provide a list of the State furnished equipment made available for this project.
 - A: There is currently a motor grader at the airport. Please see Contract Technical Specifications paragraphs (I) D. and (VI)H
- 4. Q: I was not able to find a place to enter previous airport management or flight experience. Where do you wish to have this listed?
 - A: Please see Bid Notices, Required Documents, Required for Award, Item 4. Experience Submittal
