ITB TITLE: Aviation Fuel Dispensing Services for Forestry in Palmer, Alaska

ITB CLOSING DATE AND TIME: CHANGED TO 2:00 p.m. on March 9, 2016.

ITB PUBLIC BID OPENING DATE AND TIME: CHANGED TO 2:00 p.m. on March 10, 2016.

The following answers a question asked by a potential bidder:

- 1. CHANGE the ITB CLOSING Date and Time to 2:00 p.m. on March 9, 2016. Late bids will be rejected.**
- 2. CHANGE the ITB PUBLIC BID OPENING Date and Time to 2:00 p.m. on March 10, 2016.**
- 3. Question:** We have a trailer-based 1000 gallon aviation fuel bowser which might qualify for use on this contract. The ITB does not specify the equipment requirements for a fuel bowser. Could you offer some guidance?

Response: The definition for "Aircraft Fuel Servicing Tank Refueler (Refueler)" on page 10 of the ITB states in part "Any refueler tank truck, tank pull trailer, tank semi-trailer, or tank refueler designed for or employed in the transportation and transfer of fuel into or from an aircraft." DNR will accept a trailer that meets all specifications including brakes. The portions of the equipment requirements that apply to the drivetrain would be applied to the tow vehicle and the rest would be applied to the trailer. Both tow vehicle and trailer would be assigned to the contract and inspected as a combination.

- 4. Bidders who have submitted a bid in response to this ITB may submit a revised bid if desired. The revised bid must be received in the DNR Procurement Office prior to 2:00 p.m. on March 9, 2016 to be considered responsive.**
- 5. In order for your bid to be considered responsive this amendment, in addition to your original or revised bid and any required supporting documentation, must be received by the DNR Procurement Office prior to the REVISED ITB CLOSING date and time.**
