Questions Received:

- Q. The criteria that SOA has established in the RFP (Sections 4.4 & 8.44) assume that the respondent will already have selected the exact personnel they would assign to the ALMR project and in fact, in which roles. Would the SOA consider a proposal that describes an innovative approach to achieving the outcomes, can describe how it will achieve those outcomes, and how similar outcomes are being achieved through this innovative approach but which does not name a specific person in the specific roles the RFP describes, would the SOA consider that omission non-responsive?
- A. Under the Best Value method, identification of the project personnel, their roles, and their past performance is critical to the state's evaluation process and to meet the state's requirements. Failure to respond with the information required in the RFP will result in the Offeror's proposal being found non-responsive.
- Q. When will the Department know if the funding has been approved for this effort?
- A. State of Alaska's funding should be known after the budget is finalized by the Legislature and signed by the Governor. DOD's funding has been approved and is available for this project.
- Q. Who is the technical contact for this effort?
