

We have reviewed the attached regulations from the Board of Massage Therapists against the statutory standards of the Administrative Procedure Act. I have reviewed this project under a specific delegation dated April 21, 2016 from the Regulations Attorney. Implementing, interpreting, and making specific AS 08.61, enacted under sec. 4, ch. 114, SLA 2014, and related temporary law transition provisions under sec. 10, ch. 114, SLA 2014, the regulations establish procedures and requirements regarding continuing education for massage therapists; and in particular clarify that one continuing education credit is the same as both one hour of classroom instruction under 12 AAC 79.210(e)(1) and one contact hour under 12 AAC 79.210(e)(2) and (3).

The attached changes are Part 2 of this regulations project; Part 1 of the regulations was filed December 18, 2015, and those regulations had an effective date of January 17, 2016 (Register 217 (April 2016)). We find no legal problems with Part 2 of the regulations. 

LICENSING AND REGULATION OF MASSAGE THERAPISTS: NOTICE OF PROPOSED REGULATIONS CHANGES BOARD OF MASSAGE THERAPISTS

BRIEF DESCRIPTION: The Board of Massage Therapists proposes to adopt new regulations relating to the licensing and practice of massage therapists, to implement new state statute in AS 08.61 by Chapter 114, SLA 2014 (HB 328).

The Board of Massage Therapists (Board) proposes to adopt new regulations in Title 12 of the Alaska Administrative Code, dealing with all aspects of the licensing and practice of massage therapists under the authority of the Board. The proposed regulations address a wide range of subjects, including initial license application, transitional license, criminal justice information, license renewal, continuing education requirements, audit and documentation, code of ethics and standards of practice, definition of terms, and other provisions as necessary to implement Chapter 114, SLA 2014 (HB 328).

Oral comments relevant to the proposed actions, including the potential costs to private persons of complying with the proposed action, may also be given at a hearing to be held during the July 22, 2015 meeting at the Atwood Bullding, 550 W. 7th Avenue, 1st Floor, Conference Room 104, Anchorage, Alaska. Written comments will not be accepted at the hearing. The hearing will begin at 1:00 p.m. to give oral testimony have had the opportunity to give oral comments. The chair of the Board may limit each participant's length of oral testimony to a time limit, determined by the chair before the hearing begins, to allow enough time for all those present and timely registered to give testimony.
